1           A CONCURRENT RESOLUTION recognizing and  
2 honoring Shelly Beaver.

3           *Whereas, Shelly Beaver was hired by the Morgan County*  
4 *Sheriff's Office on January 1, 1987;*

5           *Whereas, She had 32 years of service to the Morgan County*  
6 *Sheriff's Office under four different administrations (Beaver,*  
7 *Garner, Downey, Myers), taking a four year absence during the*  
8 *Weddle administration;*

9           *Whereas, While serving as jail matron, Shelly Beaver assisted*  
10 *in scheduling meals and activities and supervising the*  
11 *distribution of meals to inmates in the Morgan County Jail, and*  
12 *she was a speaker at the Sheriff Conferences where she*  
13 *addressed new matrons;*

14           *Whereas, Shelly was instrumental in the construction and*  
15 *move from the "old jail" to the current facility;*

16           *Whereas, She had more than 20 years of involvement in the*  
17 *Indiana Sheriffs' Association South Youth Leadership Camp;*

18           *Whereas, She served as a Relay For Life coordinator and sat*  
19 *on the board for the United Way of Central Indiana;*

20           *Whereas, In providing her services with kindness and dignity,*  
21 *Shelly Beaver exemplified the best of Hoosiers and Morgan*  
22 *County and had a positive impact on everyone she came in*  
23 *contact with because of her dedication to her faith and her*

1        *Whereas, Shelly Beaver's excellence and devotion to duty are*  
2        *recognized in the acknowledgment of her retirement from the*  
3        *Morgan County Sheriff's Office: Therefore,*

4                    *Be it resolved by the House of Representatives*  
5                    *of the General Assembly of the State of Indiana,*  
6                    *the Senate concurring:*
