## HOUSE CONCURRENT RESOLUTION

---

1           A CONCURRENT RESOLUTION honoring Mason Parris.

2           *Whereas, Lawrenceburg High School wrestler Mason Parris*  
3           *is a three time state wrestling champion;*

4           *Whereas, Senior Mason Parris won his third consecutive 220*  
5           *pound crown at the Indiana High School Athletic Association*  
6           *(IHSAA) Wrestling State Finals at Bankers Life Fieldhouse in*  
7           *Indianapolis;*

8           *Whereas, Mason Parris is just the sixth individual to win*  
9           *three state championships in the same weight class and the first*  
10          *since Franklin Central's Jake O'Brien won three straight at 215*  
11          *pounds from 2001-2003;*

12          *Whereas, In the title match, Parris (47-0) defeated*  
13          *Merrillville senior Brandon Streck (33-2) by a pin in the second*  
14          *period, marking the 11th title winning pin in his high school*  
15          *career and breaking a record that has stood since 1938;*

16          *Whereas, Mason Parris's career record is 206-1 with his only*  
17          *loss in high school coming in his freshman year appearance at*  
18          *the state finals, where he narrowly lost in the 182 pound*  
19          *semifinal;*

20          *Whereas, Mason Parris, who will be wrestling at the*  
21          *University of Michigan, won four matches at the state finals to*  
22          *end his high school wrestling career with a 152 match win*  
23          *streak that dates back to the start of his sophomore season;*

24          *Whereas, In addition to his championship title, Mason Parris*



1     *was named the Mental Attitude Award winner in wrestling by*  
2     *the IHSAA; and*

3             *Whereas, Outstanding accomplishments such as this deserve*  
4     *special recognition: Therefore,*

5                     *Be it resolved by the House of Representatives*  
6                     *of the General Assembly of the State of Indiana,*  
7                     *the Senate concurring:*

8             SECTION 1. That the Indiana General Assembly  
9     congratulates Mason Parris on winning his third Indiana state  
10    wrestling title and wishes him continued success in all his  
11    future endeavors.
