1           A CONCURRENT RESOLUTION memorializing Shacarra  
2 Lashae Hogue.

3           *Whereas, Shacarra Lashae Hogue of Fort Wayne, Indiana,*  
4 *passed away January 7, 2018, at the age of 23;*

5           *Whereas, Shacarra Lashae Hogue was born on December 10,*  
6 *1994, to Samantha Hogue-Figgs and Sheldon Abernathy;*

7           *Whereas, Shacarra was an active member of her community;*  
8 *involved in the New Haven High School color guard and after*  
9 *graduating from high school was a journalist while in college*  
10 *for the Vincennes University Trail Blazer;*

11           *Whereas, Shacarra was a member of the Today's Black*  
12 *Woman organization, as well as the Love International Fashion*  
13 *Group;*

14           *Whereas, Shacarra had her life cut short on January 7, 2018,*  
15 *due to a serious violation of state safety codes by her employer;*

16           *Whereas, Shacarra was preceded in death by her*  
17 *grandparents, Reverend Madison and Mrs. Willie Mae Hogue*  
18 *and is survived by her mother, Samantha Hogue-Figgs; her*  
19 *stepfather, Jerry L. Figgs; her father, Sheldon Abernathy; her*  
20 *grandmother, Carrie Abernathy; brothers, Brandon Hogue and*  
21 *Deonta'e Figgs; nieces, Lakyla Hogue and Rionna Hogue; and*  
22 *nephew, Braydon Hogue;*

23           *Whereas, The facts surrounding Shacarra's death motivated*  
24 *the filing of House Bill 1341 during the first Regular Session of*



1 *the Indiana General Assembly in 2019, and her death*  
2 *highlights the need to strengthen Indiana's laws sanctioning*  
3 *businesses that knowingly violate state safety codes; and*

4 *Whereas, The Indiana General Assembly passed House Bill*  
5 *1341 on April 10, 2019: Therefore,*

6 *Be it resolved by the House of Representatives*  
7 *of the General Assembly of the State of Indiana,*  
8 *the Senate concurring:*

9 SECTION 1. That the Indiana House of Representatives  
10 expresses its deepest sympathy to the family of Shacarra Lashae  
11 Hogue.

12 SECTION 2. That the Principal Clerk of the House of  
13 Representatives transmit copies of this resolution to the family
