1 A CONCURRENT RESOLUTION welcoming the 2017 Breeders
2 Crown to Hoosier Park in Anderson, Indiana, and congratulating the
3 Indiana Standardbred industry and its partners on this accomplishment.

4 *Whereas, The Hambletonian Society, Inc. annually*
5 *sponsors the Breeders Crown Championship Series, the*
6 *premier Standardbred racing series in North America;*

7 *Whereas, For the first time in Indiana horse racing history,*
8 *the Hambletonian Society has bestowed the high honor of*
9 *hosting the 2017 Breeders Crown Championship Series on*
10 *Hoosier Park, which will serve as the unique venue for this*
11 *year's races October 27-28 in Anderson, Indiana;*

12 *Whereas, The Breeders Crown is expected to draw*
13 *thousands of horse racing fans to Madison County and*
14 *surrounding communities resulting in the expenditure of*
15 *millions of tourism dollars and much favorable publicity for*
16 *Indiana and its horse racing industry;*

17 *Whereas, The selection of Hoosier Park to host the*
18 *Breeders Crown is further recognition of Indiana's*
19 *dominance in Standardbred racing and Hoosier Park's*
20 *emergence as one of the leading Standardbred tracks in*

22 *Whereas, The Hambletonian Society's decision to select*
23 *Indiana as the site for the 2017 Breeders Crown would not*
24 *have occurred but for the hard work, dedication, and*

4 *Be it resolved by the House of Representatives*

7 SECTION 1. That the Indiana General Assembly and the State of
8 Indiana welcome the 2017 Hambletonian Society's Breeders Crown
9 Championship Series and its thousands of fans, who will watch the
10 races at Hoosier Park and on television around the world.

11 SECTION 2. That the Indiana General Assembly and the State of
12 Indiana congratulate the Indiana Standardbred Association, Inc., the
13 Indiana Horse Racing Commission, city of Anderson, Madison County,
14 Indiana, and Hoosier Park for their many efforts to attract the Breeders
15 Crown to Indiana.
