1           A CONCURRENT RESOLUTION memorializing Vince Klein.

2           *Whereas, Vincent W. Klein, New Albany, passed away on*  
3           *May 26, 2016, at the age of 62;*

4           *Whereas, Vincent Klein graduated from Flaget High*  
5           *School in Louisville, Kentucky, in 1971, and attended*  
6           *Bellarmino College in Louisville, Kentucky, receiving a*  
7           *Bachelor of Arts degree;*

8           *Whereas, Vincent Klein also attended Indiana University*  
9           *Southeast in New Albany and earned a Master of Science*  
10          *degree in social work from the University of Louisville (Kent*  
11          *School of Social Work) in Louisville, Kentucky;*

12          *Whereas, With the help of some dedicated community*  
13          *members, Vincent Klein established the Floyd County Youth*  
14          *Services Bureau and helped develop many community*  
15          *programs, including after school programming and the local*  
16          *youth shelter;*

17          *Whereas, Vincent Klein also served as chairperson for the*  
18          *Step Ahead Council from its inception;*

19          *Whereas, When the funding for the initiative was*  
20          *eliminated, Vincent Klein felt it was vital to continue the*  
21          *council and continued to chair the Step Ahead Council until*  
22          *his death;*

23          *Whereas, In recognition of his devoted service and*

2     *Vincent Klein was honored with numerous awards including*  
3     *a Sagamore of the Wabash presented by Evan Bayh,*  
4     *Indiana's 46th governor; and*

5             *Whereas, Vincent Klein spent his entire professional career*  
6     *as a devoted advocate for children and their families:*
