5 *rural influences with nearly 80,000 residents calling it home;*

6 *Whereas, Floyd County is the second smallest county in*
7 *Indiana by overall land mass and was created in 1819;*

8 *Whereas, The residents of Floyd County have embraced*
9 *business and economic development opportunities throughout*
10 *their history from shipbuilding and plate glass manufacturing*
11 *to advanced manufacturing and space technology;*

12 *Whereas, The residents of Floyd County embrace their history*
13 *and work hard to preserve local landmarks and historic places*
14 *including the Scribner House, Culbertson Mansion, Town*
15 *Clock Church, Division Street School, and Cardinal Ritter*
16 *home;*

17 *Whereas, The residents of Floyd County recognize the need*
18 *to preserve nature and enjoy the many parks throughout the*
19 *county that provide opportunities for recreation and outdoor*
20 *activities;*

21 *Whereas, The residents of Floyd County champion the talent*
22 *and creativity of craftspeople, artists, and musicians in*
23 *Southern Indiana during annual celebrations including Art on*
24 *the Parish Green and Harvest Homecoming;*

2 *the Duncan Tunnel, a train tunnel and the longest of its kind in*
3 *the state of Indiana; New Albany High School, which is the first*
4 *public high school in the state of Indiana; the first student-run*
5 *radio station in the state of Indiana; two Indiana Mr.*
6 *Basketball winners; a Major League Baseball Hall of Fame*
7 *inductee; and two Miss Indiana winners;*

8 *Whereas, The success of Floyd County is a result of the labor,*
9 *talent, and industriousness of its residents; and*

10 *Whereas, The residents of Floyd County are proud of their*
11 *heritage and work hard to preserve it for future residents:*
