1 A CONCURRENT RESOLUTION urging the Indiana Department
2 of Transportation to rename Mile Marker 46-47 of the Hoosier
3 Heartland Highway the "Mark S. Davis Memorial Mile".

4 *Whereas, Mark S. Davis, of West Lafayette, passed away on*
5 *Saturday, March 4, 2017, at the age of 63;*

6 *Whereas, Mark Davis graduated from West Lafayette High*
7 *School and Indiana University, where he earned a law*
8 *degree;*

9 *Whereas, Mark Davis began his career working in*
10 *economic development in Indianapolis, the Greater Lafayette*
11 *area, and Flint, Michigan, before opening an independent*
12 *law practice in Lafayette;*

13 *Whereas, His career highlights include helping to bring the*
14 *Subaru plant to Lafayette, working on agreements with the*
15 *United States and Canada on the Blue Water Bridge that*
16 *spans our two countries, and helping to promote the Hoosier*
17 *Heartland Highway; and*

18 *Whereas, The death of Mark S. Davis left a huge void in the*
19 *lives of all who knew him; he will be greatly missed:*
20 *Therefore,*

21 *Be it resolved by the House of Representatives*
22 *of the General Assembly of the State of Indiana,*
23 *the Senate concurring:*



1 SECTION 1. That the Indiana General Assembly expresses its
2 deepest sympathies to the family of Mark S. Davis and urges the
3 Indiana Department of Transportation to honor his memory by
4 renaming Mile Marker 46-47 of the Hoosier Heartland Highway the
5 "Mark S. Davis Memorial Mile".

6 SECTION 2. That the Principal Clerk of the House of
7 Representatives transmit copies of this resolution to the family of Mark
8 S. Davis and the Commissioner of the Indiana Department of
9 Transportation.
