HOUSE JOINT RESOLUTION No. 6

DIGEST OF INTRODUCED RESOLUTION

Citations Affected: Article 4, Section 5 of the Constitution of the State of Indiana.

Synopsis: Redistricting commission. Requires the general assembly to establish a commission to draw congressional and legislative districts not later than July 1, 2027. This proposed amendment has not been previously agreed to by a general assembly.

Effective: This proposed amendment must be agreed to by two consecutive general assemblies and ratified by a majority of the state's voters voting on the question to be effective.

A JOINT RESOLUTION proposing an amendment to Article 4, Section 5 of the Indiana Constitution concerning redistricting.

Be it resolved by the General Assembly of the State of Indiana:

1 SECTION 1. The following amendment to the Constitution of the
2 State of Indiana is proposed and agreed to by this, the One Hundred
3 Twenty-Second General Assembly of the State of Indiana, and is
4 referred to the next General Assembly for reconsideration and
5 agreement.

6 SECTION 2. ARTICLE 4, SECTION 5 OF THE CONSTITUTION
7 OF THE STATE OF INDIANA IS AMENDED TO READ AS
8 FOLLOWS: Section 5. (a) The General Assembly ~~elected during the~~
9 ~~year in which a federal decennial census is taken~~ shall fix by law the
10 number of Senators and Representatives. ~~and apportion them among~~
11 ~~districts according to the number of inhabitants in each district, as~~
12 ~~revealed by that federal decennial census.~~

13 (b) **Not later than July 1, 2027, the General Assembly shall**



- 1 **establish by law a commission to draw congressional and legislative**

- 3 **(1) the number of inhabitants in each district, as revealed by**
- 4 **the most recent federal decennial census; and**
- 5 **(2) other criteria established by law.**
- 6 **(c) The territory in each district shall be contiguous.**
