11       *and the Holy Family Catholic Church;*

12       *Whereas, Representative Ziemke grew up on her family farm*  
13       *in Hamburg, Indiana, and quickly learned hard work and the*  
14       *value of a dollar;*

15       *Whereas, Representative Ziemke is married to her husband,*  
16       *Tim, and has two sons, Sean and Connor; and*
