1 A HOUSE RESOLUTION honoring Representative Dave
2 Frizzell.

3 *Whereas, Representative Dave Frizzell left the House*
4 *Chamber for the last time at the end of the 2019 legislative*
5 *session;*

6 *Whereas, Representative Frizzell was first elected to*
7 *represent the citizens of House District 93 in 1992;*

8 *Whereas, During his time in the House of Representatives,*
9 *Representative Frizzell served as chair of the House Committee*
10 *on Family, Children and Human Affairs, where he was a strong*
11 *advocate for Hoosier children;*

12 *Whereas, Representative Frizzell also served on the House*
13 *committees on Public Health and Utilities, Energy and*

1 *Telecommunications, among others;*

2 *Whereas, Representative Frizzell served the House*
3 *Republican Caucus for many years in leadership positions*
4 *including: Republican Minority Whip from 2007 to 2010;*
5 *Republican Majority Whip from 2011 to 2014; and Assistant*
6 *Majority Floor Leader from 2015 until his retirement in 2019;*

7 *Whereas, Representative Frizzell was born in Baltimore,*
8 *Maryland, settled in Indiana in 1978, and moved to House*
9 *District 93 in 1985;*

10 *Whereas, Representative Frizzell married life-long Hoosier*
11 *Valda VanNess in 1980 and started his family in 1982;*

12 *Whereas, Representative Frizzell and Valda have two sons*
13 *and nine grandchildren and are active covenant partners at*
14 *CityLife Church in Greenwood, Indiana;*

15 *Whereas, Since his election to the Indiana House of*
16 *Representatives, Representative Frizzell has served in*
17 *numerous leadership positions for the American Legislative*
18 *Exchange Council, including as the 2012 National Chair, and*
19 *was named their Legislator of the Year in 2014; and*

20 *Whereas, Representative Frizzell served his constituency*
21 *loyally and faithfully since his election to the House of*
22 *Representatives: Therefore,*

23 *Be it resolved by the House of Representatives of the*
24 *General Assembly of the State of Indiana:*

25 SECTION 1. That the Indiana House of Representatives bids
26 a fond farewell to Representative Dave Frizzell. The House of
27 Representatives saw only good things during his tenure.
28 Legislators and staff alike miss him greatly. His departure left
29 a void that never will be truly filled.

30 SECTION 2. That the Principal Clerk of the House of
31 Representatives transmit copies of this resolution to
32 Representative Dave Frizzell and his family.
