7 *Representative Reardon served as vice chair of the*
8 *Environmental Affairs Committee, and was also a member of*
9 *Roads and Transportation; Commerce, Small Business, and*
10 *Economic Development; Ways and Means; Utilities, Energy,*
11 *and Telecommunications; and was ranking minority member*
12 *on: the Statutory Committee on Interstate and International*
13 *Cooperation; the Government and Regulatory Reform*
14 *Committee, and the Select Committee on Government*

2 *elected to the Indiana House of Representatives;*

3 *Whereas, She also now serves as the chair of the Board of*
4 *Hispanic Caucus Chairs, which is a national nonpartisan*
5 *organization made up of elected Latino officials who serve in*
6 *various state leadership positions, and also serves on the board*
7 *of directors of the National Association of Latino Elected*
8 *Officials and as chair of the Educational Fund, a nonpartisan*
9 *organization that facilitates full Latino participation in the*
10 *American political process;*

11 *Whereas, Representative Reardon was elected Indiana*
12 *House Democratic Caucus Chair in 2018;*

13 *Whereas, Representative Reardon has served on the Indiana*
14 *Commission for Women; the Market Development Recycling*
15 *Board; the Minority and Women's Business Enterprise*
16 *Commission; the Hispanic/Latino Affairs Commission; and the*
17 *Indiana Commission to Combat Substance Abuse;*

18 *Whereas, Representative Reardon has been married to her*
19 *husband, Matt, for more than 20 years, and they reside in*
20 *Munster with their two children, Victoria and Christian; and*

21 *Whereas, Representative Reardon has served her*
22 *constituency loyally and faithfully since her election to the*
23 *Indiana House of Representatives: Therefore,*

24 *Be it resolved by the House of Representatives of the*
25 *General Assembly of the State of Indiana:*

26 SECTION 1. That the Indiana House of Representatives
27 honors State Representative Mara Candelaria Reardon for her
28 years of service.
