1 A HOUSE RESOLUTION congratulating the Lincoln 2 Amphitheatre, Lincoln City, on the occasion of the 30th 3 anniversary of its inaugural season.

Whereas, As one of the largest roofed amphitheaters in the
United States, the Lincoln Amphitheatre seats 1,500 in an
outdoor venue that is located in the woods where Abraham
Lincoln walked as a boy;

*Whereas, From the age of 7 until 21, Abraham Lincoln lived, worked, and learned in Lincoln City;*

Whereas, The amphitheatre, which is located in Lincoln
State Park, was dedicated in 1987 and served as the home of
the Young Abe Lincoln musical outdoor drama for 19 years;

Southern Indiana and the Lincoln Boyhood Drama Association (LBDA) operated the amphitheatre and produced Young Abe 2 Lincoln, which was presented for the final time in August 2005 3 when funding was lost; 4 Whereas, Local efforts to restore funding for a 5 Lincoln-based production were successful in 2007, with the 6 7 Indiana General Assembly approving \$1.6 million for facility upgrades and for a production of a new Abraham Lincoln play; 8 9 Whereas, Following the 2014 season, the amphitheatre was 10 again closed for the majority of the 2015 season; Whereas, The Indiana Office of Tourism Development and 11 the Indiana Department of Natural Resources began a 12 partnership midway through the 2015 season in an attempt to 13 14 bring the Lincoln play back for the 2016 season in conjunction with the state's bicentennial celebration: 15 Whereas, A successful trial event was held on October 24, 16 17 2015, featuring a tribute performance to the Beatles and the Rolling Stones; 18 19 Whereas, The winter of 2015-2016 was spent coordinating contracts and logistics for six performances of the Lincoln 20 musical drama, as well as nine additional concert 21 performances, bringing the final count for the 2016 22 performance series to 15 events; 23 Whereas, The 2016 season was filled with excitement and 24 success for the Lincoln Amphitheatre, much like the grand 25 opening in 1987; and 26 Whereas, Over the nearly 30 years of existence, the Lincoln 27 Amphitheatre's primary use has been to showcase the life and 28 history of Abraham Lincoln, particularly as it relates to the 29

- years he resided in southern Indiana: Therefore 30
