attended the United States Naval Academy, received his
 commission in 1983, became a naval flight officer in 1985, and
 received a Master of the Arts in International Security Policy
 from George Washington University;

Whereas, Vice Admiral Buck has served as a commander of 5 6 the Patrol and Reconnaissance Force with the U.S. 5th and 7th 7 Fleets, served as Chief of Staff of Strategy, Plans, and Policy of the Joint Staff, served as Director of the 21st Century Sailor 8 9 Office where his portfolio included the Navy's prevention and response programs for a number of destructive human 10 behaviors, and served as Commander for the U.S. Naval Forces 11 Southern Command/U.S. 4th Fleet; 12

Whereas, Vice Admiral Buck's early at-sea tours were with the "Fighting Marlins" of Patrol Squadron 40, aboard the USS Theodore Roosevelt as a catapult and arresting gear division officer, and as a department head and eventual commander of the "Tridents" of VP-26;

18 Whereas, Vice Admiral Buck's shore and staff assignments 19 included the Air Test and Evaluation Squadron, Bureau of 20 Naval Personnel, Office of the Chief of Naval Operations staff 21 as executive assistant to the deputy chief of Naval Operations 22 for Warfare Requirements and Programs, and an interim 23 assignment with the National Reconnaissance Office, and as a 24 member of the Navy's Space Cadre;

Whereas, Vice Admiral Buck performed meritorious and 25 distinguished service during many conflicts including the Cold 26 War, Gulf War, and Global War On Terror, as well as 27 Operations Desert Shield, Desert Storm, Allied Force, Iraqi 28 Freedom, and Enduring Freedom, along with humanitarian 29 missions including Operations Tomodachi, Continuing 30 Promise, and Martillo which provided rescue, aid, and comfort 31 following earthquakes, tsunamis, and radiological disasters, 32 and he led major counter-narcotics efforts, as well as a seven 33 nation search for the lost Argentinian submarine ARA San 34 Juan: 35
