1 A HOUSE RESOLUTION honoring Representative Kathy
2 Kreag Richardson.

3 *Whereas, Representative Richardson, who was first elected*
4 *to represent the citizens of House District 29 in 1992, will be*
5 *leaving the House Chamber for the last time at the end of the*
6 *2018 legislative session;*

7 *Whereas, During her time in the House of Representatives,*
8 *Representative Richardson has served as chairwoman and vice*
9 *chairwoman of the Elections and Apportionment Committee, as*
10 *well as a member of the Legislative Council, Judiciary*
11 *Committee, Courts and Criminal Code Committee, Statutory*
12 *Committee on Ethics, Statutory Committee on Interstate and*
13 *International Cooperation, Economic Growth and Regulatory*
14 *Relief, and Local Government;*

1 *Whereas, Representative Richardson was the first woman in*
2 *Indiana history to be elected to a leadership position in the*
3 *Indiana House. She has served the Republican Caucus as*
4 *caucus chairwoman since 2000, where she has played an*
5 *invaluable role in guiding legislative policy, building relations*
6 *among lawmakers and staff, and helping her caucus's newly*
7 *elected members;*

8 *Whereas, Representative Richardson has also been a leader*
9 *in the legislature on election related issues, including measures*
10 *to create online voter registration, require centralized counting*
11 *on absentee ballots and establishing countywide vote centers.*
12 *She has also served a leading role in the state's redistricting*
13 *process;*

14 *Whereas, In addition to her service as a state representative,*
15 *Representative Richardson works as an election administrator*
16 *for Hamilton County. She is involved in many organizations*
17 *from her home county including the Noblesville Chamber of*
18 *Commerce, Association of Clerks of the Circuit Court,*
19 *Association of Indiana Counties, Hamilton County Fraternal*
20 *Order of Police, Hamilton County Humane Society, Hamilton*
21 *County Historical Society, NHS Alumni Association, First*
22 *Christian Church of Noblesville, Noblesville Riverwalk*
23 *Committee, Hamilton County 4-H Council, and as a Hamilton*
24 *County Extension Board member, among many others. She is*
25 *a passionate supporter of local sports, and you can always*
26 *catch her at a local school's sports games cheering on the*
27 *team;*

28 *Whereas, Representative Richardson graduated from*
29 *Noblesville High School and attended Purdue University;*

30 *Whereas, Representative Richardson is married to Perry*
31 *Williams; and*
