ENGROSSED SENATE BILL No. 6

DIGEST OF SB 6 (Updated March 10, 2021 3:38 pm - DI 133)

Citations Affected: IC 4-20.5; IC 4-23.

Synopsis: State house monument to suffragists. Extends the Indiana women's suffrage centennial commission (IWSCC) until July 1, 2024. Requires the IWSCC to commission the creation of a suitable monument to the people of Indiana active in the women's suffrage movement and the ratification of the Nineteenth Amendment to the Constitution of the United States. Requires the department of administration to install the monument commissioned by the IWSCC on the grounds of the state house before January 1, 2024.

Effective: Upon passage.

ENGROSSED SENATE BILL No. 6

A BILL FOR AN ACT to amend the Indiana Code concerning state offices and administration.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 4-20.5-21-3 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: **Sec. 3. Before January 1, 2024, the department**
4 **shall install on the grounds of the state house a monument**
5 **commissioned by the Indiana women's suffrage centennial**
6 **commission under IC 4-23-25.1-7.**
7 SECTION 2. IC 4-23-25.1-7, AS ADDED BY P.L.87-2019,
8 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
9 UPON PASSAGE]: Sec. 7. The commission shall do the following:
10 (1) Plan and develop activities that are appropriate to
11 commemorate the passage of the Nineteenth Amendment to the
12 Constitution of the United States.
13 (2) Encourage and assist:
14 (A) state agencies (as defined in IC 4-13-1-1);
15 (B) units of local government; and
16 (C) private organizations within Indiana;
17 in coordinating, organizing, and participating in activities that

1 commemorate the Nineteenth Amendment to the Constitution of

3 (3) Work to create a legacy that elevates the contributions of
4 women and men with a connection to Indiana who were

8 **(4) Commission the creation of a suitable monument to the**
9 **people of Indiana active in the women's suffrage movement**

12 SECTION 3. IC 4-23-25.1-17, AS ADDED BY P.L.87-2019,

14 UPON PASSAGE]: Sec. 17. This chapter expires July 1, ~~2021~~ **2024**.
15 SECTION 4. **An emergency is declared for this act.**
