SENATE BILL No. 7

DIGEST OF SB 7 (Updated February 5, 2015 2:18 pm - DI 103)

Citations Affected: IC 6-1.1; IC 9-22.

Synopsis: Abandoned mobile homes. Makes changes to the procedure in current law for the sale or salvage of an abandoned mobile home located on private property. Provides, except in the case of an abandoned mobile home offered for sale at auction, that the bureau of motor vehicles may not transfer the title to a mobile home or change the names on the title to a mobile home unless the owner holds a valid permit issued by the county treasurer. Provides that a permit to move, or transfer title to, a mobile home expires 30 days after the permit is issued.

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

Be it enacted by the General Assembly of the State of Indiana:

The permit is invalid after the permit expires. If 10 the owner wishes to move, or transfer title to, the mobile home 11 after the permit has expired, the owner must obtain a new permit 12 under this section. 13 SECTION 2. IC 6-1.1-7-10.4 IS AMENDED TO READ AS 14 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 10.4. (a) This section 15 does not apply to a mobile home that is offered for sale at auction 16 under IC 9-22-1.5 for the transfer resulting from the auction. 17 (b) The owner of a mobile home who sells the mobile home to 18 another person shall provide the purchaser with the permit required by 19 section 10(b) 10(c) of this chapter before the sale is consummated. 20 SECTION 3. IC 9-22-1.5-1.5 IS ADDED TO THE INDIANA 21 CODE AS A NEW SECTION TO READ AS FOLLOWS 22 [EFFECTIVE JULY 1, 2015]: Sec. 1.5. For purposes of this chapter, 23 a mobile home is considered "abandoned" if three (3) or more of 24 the following conditions exist with respect to the mobile home: 25 (1) The mobile home has been unoccupied by humans for 26 thirty (30) days or more. 27 (2) Electric service to the mobile home has been disconnected 28 for thirty (30) days or more. 29 (3) Natural gas or propane service to the mobile home has 30 been disconnected for thirty (30) days or more. 31 (4) Water service to the mobile home has been disconnected 32 for thirty (30) days or more. 33 (5) One (1) or more windows in the mobile home have been 34 struck by a bullet or other ammunition. 35 (6) Metal siding has been vandalized or removed, including 36 for purposes of salvage. 37 (7) The mobile home is partially or wholly detached from its 38 foundation. 39 (8) The roof is partially or completely removed, burned, or 40 collapsed.

1 [EFFECTIVE JULY 1, 2015]: Sec. 2. A private property owner who 2 finds a mobile home that the person believes to be abandoned on 3 property the person owns or controls, including rental property, may 4 sell or salvage the mobile home if it was built at least fifteen (15) 5 years ago and has been left without permission on the owner's 6 property for at least thirty (30) sixty (60) days. The thirty (30) sixty 7 (60) day period begins on the day the property owner sends notice 8 under section 3 of this chapter to the owner of the mobile home. 9 SECTION 5. IC 9-22-1.5-3, AS AMENDED BY P.L.262-2013, 10 SECTION 108, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 3. (a) A property owner shall send 11 12 notice of a mobile home described in section 2 of this chapter as 13 follows: 14 (1) To the owner of the mobile home at the last known address of 15 the owner as shown by: (A) the records of the bureau, if the last known address of 16 17 the owner of the mobile home is shown in the records of 18 the bureau: or 19 (B) the records of the county assessor in which the mobile 20 home is located, if: 21 (i) the unique serial number or special identification 22 number assigned to the mobile home is removed or 23 otherwise illegible; or 24 (ii) the last known address of the owner of the mobile 25 home is not shown in the records of the bureau. 26 If the property owner is unable to determine the address of the 27 mobile home owner, the property owner may serve the mobile 28 home owner by posting the notice on the mobile home. 29 (2) To: 30 (A) a lienholder with a perfected security interest in the mobile 31 home; or 32 (B) any other person known to claim an interest in the mobile 33 home; 34 as shown by the records of the bureau. 35 Notice under this subsection must include a description of the mobile 36 home, the location of the mobile home, and a conspicuous statement 37 that the mobile home is on the owner's property without the owner's 38 permission. If the owner of a mobile home changes the owner's address 39 from that maintained in the records of the bureau, the owner shall 40 immediately notify the property owner of the new address. 41 (b) A property owner may provide notice under subsection (a) by

1 (1) Certified mail, return receipt requested. 2 (2) Personal delivery. 3 (3) Electronic service under IC 9-22-1-19. 4 (c) If, before the thirty (30) day period described in section 2 of this 5 chapter expires, the mobile home owner requests by certified mail, 6 return receipt requested, additional time to remove the mobile home, 7 the period described in section 2 of this chapter shall be extended by 8 an additional thirty (30) days. The mobile home owner may only 9 request one (1) thirty (30) day extension of time. 10 SECTION 6. IC 9-22-1.5-4, AS AMENDED BY P.L.125-2012, 11 SECTION 126. IS AMENDED TO READ AS FOLLOWS 12 [EFFECTIVE JULY 1, 2015]: Sec. 4. The property owner shall: 13 (1) request that a search be performed in the records of the bureau 14 or the county assessor, in accordance with section 3(a)(1) of 15 this chapter, for the name and address of the owner of the mobile 16 home and the name and address of any person holding a lien or 17 security interest on the mobile home; 18 (2) after receiving the results of the search required by 19 subdivision (1), give notice by certified mail, return receipt 20 requested, or in person, to: 21 (A) the last known address of the owner of the mobile home; 22 (B) to any lien holder with a perfected security interest in the 23 mobile home; and to all other persons known to claim an 24 interest in the mobile home. 25 (C) the county treasurer of the county in which the mobile 26 home is located. 27 The notice must include a description of the mobile home, the 28 location of the mobile home, a demand that the mobile home be 29 removed within a specified time not less than ten (10) days after 30 receipt of the notice, and a conspicuous statement that unless the 31 mobile home is removed within that time, the mobile home will 32 be advertised for sale and offered for sale by auction at a specified 33 time and place; 34 (3) advertise that the mobile home will be offered for sale at 35 public auction. in conformity with IC 26-1-7-210 and 36 IC 26-1-2-328. The advertisement of sale must be published once 37 a week for two (2) consecutive weeks in a newspaper of general 38 circulation in the county where the mobile home has been left 39 without permission. The advertisement must include a description 40 of the mobile home, the name of the owner of the mobile home, 41 if ascertainable, and the time and place of the sale. The sale must

42 take place at least fifteen (15) days after the first publication. If

COMMITTEE REPORT

Madam President: The Senate Committee on Homeland Security and Transportation, to which was referred Senate Bill No. 7, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Delete the title and insert the following:

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

Page 1, between the enacting clause and line 1, begin a new paragraph and insert:

"SECTION 1. IC 5-13-9-8, AS AMENDED BY P.L.202-2011, SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 8. Any investing officer of a political subdivision that makes a deposit in any deposit or other account may be required to pay a service charge to the depository in which the funds are deposited, if the depository requires all customers to pay the charge for providing that service. However, the service charge imposed must be considered in the computation of the interest rate for determining which depositories are entitled to investments as prescribed by sections 4 and 5 of this chapter. If the total service charge cannot be computed before the investment, the investing officer shall estimate the service charge and adjust the interest rate based on this estimate. The service charge may be paid:

(1) by direct charge to the deposit or other account; or

(2) in a manner that subtracts the service charge from interest earned on the funds in the deposit or other account.

If the manner described in subdivision (2) is used to pay the service charge, the political subdivision must report the net interest deposited in the political subdivision's financial records, and the political subdivision is not required to report the amount of the service charge subtracted in the political subdivision's financial records.".
