#### DIGEST OF INTRODUCED BILL

Citations Affected: IC 35-42-2-1.

**Synopsis:** Battery on a sports official. Increases the penalty for battery if it is committed against a person certified as a referee, umpire, or athletic official.

Effective: July 1, 2014.
