SENATE BILL No. 15

DIGEST OF INTRODUCED BILL

Citations Affected: IC 22-5-7.

Synopsis: Use of consumer reports for employment purposes. Prohibits an employer from using a consumer report for employment purposes unless certain conditions apply. Allows a consumer to bring a civil action against an employer for a violation of this provision. Provides that if the attorney general has reason to believe that an employer has violated the provision, the attorney general may bring one or both of the following: (1) An action to enjoin the violation. (2) An action to recover damages sustained by Indiana residents as a result of the violation. Makes it: (1) a Class B infraction for a knowing or intentional violation of the provision; or (2) a Class A infraction if an employer has a prior unrelated judgment for a violation of the provision.

Effective: July 1, 2015.

A BILL FOR AN ACT to amend the Indiana Code concerning labor and safety.

Be it enacted by the General Assembly of the State of Indiana:

Except as otherwise provided under state or federal law, 31 and to the extent not inconsistent with the federal Fair Credit 32 Reporting Act (15 U.S.C. 1681 et seq.), an employer may not use a 33 consumer report for employment purposes unless the following 34 apply: 35 (1) The information used from the consumer report is 36 substantially job related in that the position that the consumer 37 holds or for which the consumer is applying is a position in 38 which the consumer has, or would have, access to money, 39 other assets, or confidential information. 40 (2) The position the consumer holds or for which the 41 consumer is applying is one (1) or more of the following: 42 (A) A managerial position.

1 to the prevailing consumer. 2 (2) Enjoin further violation of this chapter by the employer. 3 Sec. 9. If the attorney general has reason to believe an employer 4 has violated or is violating section 7 of this chapter, the attorney 5 general may, in conjunction with or independent of an action 6 authorized under 15 U.S.C. 1681s(c), do one (1) or more of the 7 following: 8 (1) Bring an action, in any court with jurisdiction, to enjoin 9 the violation. 10 (2) Bring an action, in any court with jurisdiction, on behalf 11 of Indiana residents to recover damages sustained by Indiana 12 residents as a result of the violation. 13 In a successful action under subdivision (1) or (2), the attorney 14 general shall be awarded the costs of the action and reasonable 15 attorney's fees, as determined by the court. 16 Sec. 10.
