SENATE BILL No. 18

A BILL FOR AN ACT to amend the Indiana Code concerning alcohol and tobacco.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 7.1-3-27-7, AS ADDED BY P.L.109-2013,
2 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2014]: Sec. 7. (a) This section applies only to a person that, on
4 January 1, 2014:
5 (1) holds the necessary permit or license from the United States
6 to own or operate an establishment to manufacture liquor; and
7 (2) does not hold any of the permits listed in section 5(a)(1) of
8 this chapter.
9 (b) A person must meet all the following requirements to be eligible
10 for an artisan distiller's permit under this section:
11 (1) Any person (except for a person under subdivision (2)) who
12 sells or furnishes liquor by the bottle or glass on the premises of
13 the artisan distillery:
14 (A) must have held for at least three (3) years an employee a
15 permit under IC 7.1-3-18-9 that authorizes the person to
16 perform bartending duties;

- 1 (B) must have completed any alcohol server program or
 2 alcohol server training program refresher courses required
 3 under IC 7.1-3-1.5; and
 4 (C) may not have any violations under this title.
- 5 (2) The applicant for the artisan distiller's permit and any
 6 management representative of the applicant must complete an
 7 alcohol server program or a trainer program established or
 8 approved under IC 7.1-3-1.5-5.5 or IC 7.1-3-1.5-6 not more than
 9 one (1) year before the date of the application for the artisan
 10 distiller's permit.
- 11 (c) Except as provided in subsection (f)(2), the person may not be
 12 required to fulfill the requirements of section 5 of this chapter.
- 13 (d) If the person is issued an artisan distiller's permit under this
 14 section, the person must meet the following requirements for the period
 15 set forth in subsection (e):
- 16 (1) Any person selling or furnishing liquor on the premises of the
 17 artisan distillery (except for a person under subsection (b)(2))
 18 must meet the requirements of subsection (b)(1).
- 19 (2) The holder of the artisan distiller's permit and any
 20 management representative of the holder of the artisan distiller's
 21 permit must successfully complete refresher courses under
 22 IC 7.1-3-1.5 not later than three (3) years after the date the holder
 23 or representative completes the initial server program or trainer
 24 program.
- 25 (e) A person who is issued an artisan distiller's permit under this
 26 section must meet the requirements in subsection (d) until the later of:
- 27 (1) three (3) years after the date on which the initial artisan
 28 distiller's permit is issued; or
 29 (2) the date that the holder of the artisan distiller's permit has one
 30 (1) twelve (12) month period without a violation of this title.
- 31 (f) Upon fulfilling the requirements of subsections (d) and (e), a
 32 person who is issued an artisan distiller's permit under this section must
 33 meet the following requirements for as long as the person holds the
 34 permit:
- 35 (1) Any person who sells or furnishes liquor on the premises of
 36 the artisan distillery (except for a person under subsection (b)(2))
 37 must have an employee permit under IC 7.1-3-18-9 and be
 38 otherwise authorized by the commission to perform bartending
 39 duties. However, the person is not required to
 40 ~~(A) hold an employee bartending permit for three (3) years~~
 41 ~~before selling or furnishing liquor; and~~
 42 ~~(B) not have any violations under this title.~~



1 (2) The holder of the artisan distiller's permit and any
2 management representative of the holder of the artisan distiller's
3 permit are subject to the same alcohol server training
4 requirements and refresher course requirements as the holder of
5 an artisan distiller's permit that meets the requirements of section
6 5 of this chapter.
