

SENATE BILL No. 26

DIGEST OF INTRODUCED BILL

Citations Affected: IC 22-5-9.

Synopsis: Use of consumer reports for employment purposes. Prohibits an employer from using a consumer report for employment purposes unless certain conditions apply. Allows a consumer to bring a civil action against an employer for a violation of this provision. Provides that if the attorney general has reason to believe that an employer has violated the provision, the attorney general may bring one or both of the following: (1) An action to enjoin the violation. (2) An action to recover damages sustained by Indiana residents as a result of the violation. Makes it: (1) a Class B infraction for a knowing or intentional violation of the provision; or (2) a Class A infraction if an employer has a prior unrelated judgment for a violation of the provision.

Effective: July 1, 2022.

SENATE BILL No. 26

A BILL FOR AN ACT to amend the Indiana Code concerning labor and safety.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 22-5-9 IS ADDED TO THE INDIANA CODE AS
2 A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2022]:
4 **Chapter 9. Use of Consumer Reports by Employers**
5 **Sec. 1. As used in this chapter, "consumer" means an individual**
6 **whose credit information and history are recorded in a consumer**
7 **report.**
8 **Sec. 2. As used in this chapter, "consumer report" has the**
9 **meaning set forth in 15 U.S.C. 1681a(d).**
10 **Sec. 3. As used in this chapter, "employer" has the meaning set**
11 **forth in IC 22-8-1.1-1.**
12 **Sec. 4. As used in this chapter, "employment purposes", when**
13 **used in connection with a consumer report, means the use of the**
14 **consumer report for the purpose of evaluating a consumer for**
15 **Indiana employment, including:**
16 **(1) employment;**
17 **(2) promotion;**



- 1 (3) reassignment; or
 2 (4) retention as an employee.

3 **Sec. 5. As used in this chapter, "Indiana employment" means**
 4 **service, including service in interstate commerce, that is performed**
 5 **by an individual:**

6 (1) for remuneration or under any contract of hire, written or
 7 oral, or expressed or implied; and

8 (2) within or both within and outside Indiana if, subject to
 9 section 6 of this chapter, the service:

10 (A) is localized in Indiana; or

11 (B) is not localized in any state, but some of the service is
 12 performed in Indiana and:

13 (i) the base of operations, or, if there is no base of
 14 operations, the place from which the service is directed
 15 or controlled, is in Indiana; or

16 (ii) the base of operations or place from which the
 17 service is directed or controlled is not in any state in
 18 which some part of the service is performed but the
 19 residence of the individual performing the service is in
 20 Indiana.

21 **Sec. 6. For purposes of section 5 of this chapter, service**
 22 **performed by an individual is considered localized in a state if:**

23 (1) the service is performed entirely within the state; or

24 (2) the service is performed both within and outside the state,
 25 but the service performed outside the state is incidental to the
 26 individual's service within the state, such as service that is
 27 temporary or transitory in nature or that consists of isolated
 28 transactions.

29 **Sec. 7. Except as otherwise provided under state or federal law,**
 30 **and to the extent not inconsistent with the federal Fair Credit**
 31 **Reporting Act (15 U.S.C. 1681 et seq.), an employer may not use a**
 32 **consumer report for employment purposes unless the following**
 33 **apply:**

34 (1) The information used from the consumer report is
 35 substantially job related in that the position that the consumer
 36 holds or for which the consumer is applying is a position in
 37 which the consumer has, or would have, access to money,
 38 other assets, or confidential information.

39 (2) The position the consumer holds or for which the
 40 consumer is applying is one (1) or more of the following:

41 (A) A managerial position.

42 (B) A position with the office of the attorney general.



- 1 (C) A position with a city, town, or county.
 2 (D) Any law enforcement position.
 3 (E) A position for which the information used from the
 4 consumer report is required to be:
 5 (i) disclosed by law; or
 6 (ii) obtained by the employer under state or federal law.
 7 (3) The employer does the following:
 8 (A) Provides to the credit reporting agencies from which a
 9 consumer report will be procured a certification described
 10 in 15 U.S.C. 1681e(a), as required by 15 U.S.C. 1681b(f).
 11 (B) Complies with 15 U.S.C. 1681b(b)(2) by:
 12 (i) providing to the consumer, at any time before the
 13 consumer report is procured, a written disclosure that a
 14 consumer report may be obtained for employment
 15 purposes; and
 16 (ii) obtaining the consumer's written authorization for
 17 the procurement of the consumer report.
 18 (C) If applicable, complies with 15 U.S.C. 1681b(b)(3)
 19 concerning adverse employment actions based in whole or
 20 in part on consumer reports.

21 **Sec. 8. (a) In addition to any remedy that a consumer may have**
 22 **under:**

- 23 (1) 15 U.S.C. 1681n with respect to a person's willful failure
 24 to comply with the federal Fair Credit Reporting Act (15
 25 U.S.C. 1681 et seq.); or
 26 (2) 15 U.S.C. 1681o with respect to a person's negligent failure
 27 to comply with the federal Fair Credit Reporting Act (15
 28 U.S.C. 1681 et seq.);

29 a consumer may bring, in any court with jurisdiction, a civil action
 30 against an employer that uses the consumer's consumer report in
 31 violation of section 7 of this chapter.

32 (b) In an action brought by a consumer under subsection (a),
 33 other than an action under the federal Fair Credit Reporting Act
 34 (15 U.S.C. 1681 et seq.) described in subsection (a)(1) or (a)(2), if
 35 the court determines that an employer has violated section 7 of this
 36 chapter, the court may do the following:

- 37 (1) Award:
 38 (A) actual damages;
 39 (B) punitive damages, in the case of a willful violation of
 40 section 7 of this chapter; and
 41 (C) court costs and reasonable attorney's fees;
 42 to the prevailing consumer.



1 **(2) Enjoin further violation of this chapter by the employer.**
2 **Sec. 9. If the attorney general has reason to believe an employer**
3 **has violated or is violating section 7 of this chapter, the attorney**
4 **general may, in conjunction with or independent of an action**
5 **authorized under 15 U.S.C. 1681s(c), do one (1) or more of the**
6 **following:**
7 **(1) Bring an action, in any court with jurisdiction, to enjoin**
8 **the violation.**
9 **(2) Bring an action, in any court with jurisdiction, on behalf**
10 **of Indiana residents to recover damages sustained by Indiana**
11 **residents as a result of the violation.**
12 **In a successful action under subdivision (1) or (2), the attorney**
13 **general shall be awarded the costs of the action and reasonable**
14 **attorney's fees, as determined by the court.**
15 **Sec. 10. An employer who knowingly or intentionally violates**
16 **this chapter commits a Class B infraction. However, the offense is**
17 **a Class A infraction if the employer has a prior unrelated**
18 **judgment for an infraction under this section.**
