## ENGROSSED SENATE BILL No. 30

---

DIGEST OF SB 30 (Updated April 3, 2017 11:59 am - DI 129)

**Citations Affected:** IC 20-51.

**Synopsis:** Student school information. Requires the department of education (department), for each spring semester and each fall semester, to distribute to each school corporation: (1) the name of each eligible school in which an eligible choice scholarship student who has legal settlement in the school corporation is enrolled; (2) the number of the eligible choice scholarship students who are enrolled in each eligible school for the school year; and (3) certain information regarding the number of students who have legal settlement in a school corporation and attend a public school maintained by another school corporation or a charter school. Requires the department to post the information on the department's Internet web site.

**Effective:** July 1, 2017.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 20-51-4-12 IS ADDED TO THE INDIANA CODE  
2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2017]: **Sec. 12. (a) Subject to subsection (b), the department shall**  
4 **distribute to each school corporation, for each spring semester and**  
5 **each fall semester, the following information:**  
6 (1) **The name of each eligible school in which an eligible choice**  
7 **scholarship student who has legal settlement in the school**  
8 **corporation is enrolled.**

Madam President: The Senate Committee on Education and Career Development, to which was referred Senate Bill No. 30, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 1, line 3, delete "The" insert "**(a) Subject to subsection (b), the**".

Page 1, line 3, delete "shall, not later than the end of" and insert "**shall distribute to each school corporation, for each spring semester and each fall semester, the following information:**

**(1) The name of each eligible school in which an eligible choice scholarship student who has legal settlement in the school corporation is enrolled.**

**(2) The number of eligible choice scholarship students described in subdivision (1) who are enrolled in each eligible school for the school year.**

**(3) The total number of students who have legal settlement in the school corporation and attend a:**

**(A) public school maintained by another school corporation in Indiana; or**

**(B) charter school located in Indiana.**

**(4) The name (or description, if the school does not have a name) of the public or charter school to which a student described in subdivision (3) has transferred.**

**(5) The number of students described in subdivision (3) who have transferred to each school described in subdivision (4).**

**(b) The department shall distribute the information described in subsection (a):**

**(1) for each spring semester, not later than December 31 of the following school year; and**

**(2) for each fall semester, not later than May 31 of the same school year.**

**(c) The department may post the information described in subsection (a) on the department's Internet web site.**

**(d) Any information distributed or posted under this section may not disclose any personally identifiable information regarding**



**a student."**
