DIGEST OF SB 33 (Updated February 3, 2014 2:32 pm - DI 73)

**Citations Affected:** IC 14-15.

**Synopsis:** Possession of glass containers on the Wabash River. Makes possessing or using glass containers within the normal high watermarks of the Wabash River a Class C infraction. Specifies certain exceptions.

**Effective:** July 1, 2014.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

## SENATE BILL No. 33

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 14-15-2-9.1 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2014]: **Sec. 9.1. (a) An individual may not possess or use a glass  
4 container for beverages within the normal high watermarks of the  
5 Wabash River.**  
6 **(b) An individual who violates this section commits a Class C  
7 infraction. Each violation may be prosecuted as a separate offense.  
8 No individual shall be placed in any legal jeopardy of any kind if  
9 the individual's possession or use of a glass container is a result of  
10 the individual's effort to remove litter previously discarded by  
11 others.**  
12 **(c) This section does not apply to a glass container for beverages  
13 stored or used inside an enclosed cabin of:**  
14 **(1) a watercraft (as defined under IC 9-13-2-198.5);**  
15 **(2) a houseboat;**  
16 **(3) a dinner boat; or**

- 1           **(4) any structure that is attached to a residence.**
- 2           **(d) This section does not apply to a glass container for beverages**
- 3           **being transported to or from:**
- 4           **(1) a watercraft (as defined under IC 9-13-2-198.5);**
- 5           **(2) a houseboat;**
- 6           **(3) a dinner boat; or**
- 7           **(4) any structure that is attached to a residence.**

 SENATE MOTION

Madam President: I move that Senate Bill 33 be amended to read as follows:

Page 1, line 5, delete "Indiana's navigable waters." and insert "**the Wabash River.**".

Page 1, after line 11, begin a new paragraph and insert:

**"(c) This section does not apply to a glass container for beverages stored or used inside an enclosed cabin of:**

- (1) a watercraft (as defined under IC 9-13-2-198.5);**
- (2) a houseboat;**
- (3) a dinner boat; or**
- (4) any structure that is attached to a residence.**

**(d) This section does not apply to a glass container for beverages being transported to or from:**

- (1) a watercraft (as defined under IC 9-13-2-198.5);**
- (2) a houseboat;**
- (3) a dinner boat; or**
- (4) any structure that is attached to a residence."**
