DIGEST OF SB 51 (Updated January 8, 2014 11:42 am - DI 84)

Citations Affected: Noncode.

Synopsis: Department of health matters. Requires, before September 1, 2014, the state department of health to: (1) adopt rules concerning the regulation of facilities for treatment of traumatic brain injuries; and (2) make recommendations to the legislative council and health finance commission concerning food handling law changes. (The introduced version of this bill was prepared by the health finance commission.)

Effective: Upon passage.

A BILL FOR AN ACT concerning health.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **As used in this**
2 **SECTION, "department" refers to the state department of health.**
3 (b) **Before September 1, 2014, the department shall adopt rules**
4 **that establish a license and provide regulations for a facility that**
5 **provides specialized treatment and services for traumatic brain**
6 **injuries.**
7 (c) **Before September 1, 2014, the department shall make to the**
8 **legislative council and health finance commission**
9 **recommendations concerning changes to the food handling laws.**
10 **Recommendations made to the legislative council must be in an**
11 **electronic format under IC 5-14-6.**
12 (d) **This SECTION expires December 31, 2014.**
13 SECTION 2. **An emergency is declared for this act.**
