Synopsis: Representation of judges in mandate of funds litigation. Urges the legislative council to assign the topic of the representation of judges and payment of attorneys fees in judicial mandate actions to an interim study committee.

ENGROSSED SENATE BILL No. 60

A BILL FOR AN ACT concerning courts and court officers.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE JULY 1, 2014] (a) As used in this
2 SECTION, "commission" refers to the commission on courts
3 established by IC 33-23-10-1.
4 (b) The general assembly urges the legislative council to assign
5 to the commission or another appropriate study committee the task
6 of studying judicial mandates, with particular emphasis on court
7 representation and the payment of attorneys fees.
8 (c) If the commission or another appropriate committee is
9 assigned the topic described in subsection (b), the commission or
10 committee shall issue to the legislative council a final report
11 containing the commission's or committee's findings and
12 recommendations, including any recommended legislation
13 concerning the topic, in an electronic format under IC 5-14-6, not
14 later than November 1, 2014.
15 (d) This SECTION expires January 1, 2015.
