ENGROSSED SENATE BILL No. 62

DIGEST OF SB 62 (Updated February 19, 2015 4:19 pm - DI 116)

Citations Affected: IC 20-32.

Synopsis: 2015 ISTEP program. Provides that the department of education (department) may waive certain assessment inspection requirements for purposes of administration of the 2015 ISTEP program. Provides that, if the department waives inspection requirements for any questions on the 2015 ISTEP program, the department must establish criteria to allow a student's parent the opportunity to inspect questions used as part of the 2015 ISTEP program in a manner that will not compromise the validity or integrity of the 2016 ISTEP program. Provides that the department may waive the administration of the social studies portion of ISTEP program during the 2015 administration of the ISTEP program.

Effective: Upon passage.

SENATE BILL No. 62

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-32-5-2.1 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: **Sec. 2.1. (a) The department may waive**
4 **inspection requirements under section 9(b)(2) of this chapter for**
5 **purposes of administration of the 2015 ISTEP program. However,**
6 **if the department waives inspection requirements for any questions**
7 **on the 2015 ISTEP program, the department shall establish**
8 **criteria to provide a student's parent the opportunity to inspect**
9 **questions used as part of the 2015 ISTEP program in a manner**
10 **that will not compromise the validity or integrity of the 2016**
11 **ISTEP program. The criteria established by the department under**
12 **this section may include a requirement that the student's parent**
13 **who inspects questions used as part of the 2015 ISTEP program**
14 **under this section must enter into a confidentiality agreement with**
15 **the department not to disclose questions inspected by the student's**
16 **parent.**

1 **(b) Nothing in this section may be construed to prohibit a parent**
2 **from requesting a rescoring under section 9 of this chapter of a**
3 **student's responses, including a student's essay, to an ISTEP**
4 **program test administered in the spring of 2015.**

5 **(c) This section expires September 1, 2016.**

6 SECTION 2. IC 20-32-5-9.1 IS ADDED TO THE INDIANA CODE
7 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE
8 UPON PASSAGE]: **Sec. 9.1. (a) Notwithstanding section 2(4) of this**
9 **chapter and 511 IAC 5-2-3(b)(3), the department may waive the**
10 **administration of the social studies portion of ISTEP program**
11 **during the 2015 administration of the ISTEP program.**

12 **(b) This section expires January 1, 2016.**

13 SECTION 3. **An emergency is declared for this act.**
