Synopsis: ISTEP panel. Establishes a panel to study alternatives to the ISTEP program tests and to make recommendations for replacing the ISTEP program.

Effective: Upon passage.

SENATE BILL No. 63

A BILL FOR AN ACT concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **The definitions**
2 **used in IC 20 apply throughout this SECTION.**

3 (b) **A panel is established to study alternatives to the ISTEP**
4 **program tests and to make recommendations for replacing the**
5 **ISTEP program under IC 20-32-5. The panel shall submit its**
6 **recommendations in a final report to the governor and, in an**
7 **electronic format under IC 5-14-6, the general assembly not later**
8 **than November 1, 2016. The panel shall consider the following**
9 **when making its recommendations:**

10 (1) **The feasibility of using existing tests other than the ISTEP,**
11 **as well as new testing approaches.**

12 (2) **Reducing testing time.**

13 (3) **Reducing costs associated with the administration of a**
14 **statewide assessment.**

15 (4) **Test transparency and fairness to schools, teachers, and**
16 **students.**

17 (c) **The panel consists of the following seventeen (17) members:**

18 (1) **The commissioner of the department of workforce**

1 development, or the commissioner's designee.

2 (2) The governor, state superintendent of public instruction,
3 speaker of the house of representatives, and president pro
4 tempore of the senate each shall each appoint (4) members
5 consisting of:

6 (A) one (1) member who is a teacher;

7 (B) one (1) member who is a principal;

8 (C) one (1) member who is a school superintendent; and

9 (D) one (1) member with technical expertise in
10 standardized testing.

11 (d) Members appointed under subsection (c)(2) shall be
12 appointed by the member's respective appointing authority not
13 later than May 1, 2016. Each member appointed under subsection
14 (c) serves at the will of the member's appointing authority.

15 (e) A quorum of the panel consists of nine (9) members.

16 (f) The governor shall call the initial meeting of the panel. At the
17 initial meeting of the panel, the members of the panel shall elect a
18 chairperson. The commissioner of the department of workforce
19 development, or the commissioner's designee, shall act as the initial
20 chairperson of the panel until the chairperson is elected under this
21 subsection. The panel shall meet at the call of the chairperson for
22 subsequent meetings of the panel.

23 (g) The state board shall provide clerical, research, and
24 administrative personnel and other assistance to support the panel.
25 The department shall provide technical assistance for the panel.

26 (h) Each member of the panel who is not a state employee is
27 entitled to receive both of the following:

28 (1) The minimum salary per diem provided by
29 IC 4-10-11-2.1(b).

30 (2) Reimbursement for travel expenses, as provided in the
31 state travel policies and procedures established by the Indiana
32 department of administration and approved by the budget
33 agency.

34 (i) Each member of the panel who is a state employee is entitled
35 to reimbursement for travel expenses actually incurred in
36 connection with the member's duties, as provided in the state travel
37 policies and procedures established by the Indiana department of
38 administration and approved by the budget agency.

39 (j) Meetings of the panel must comply with IC 5-14-1.5.

40 (k) This SECTION expires January 1, 2017.

41 SECTION 2. An emergency is declared for this act.
