## SENATE BILL No. 65

---

DIGEST OF SB 65 (Updated January 24, 2018 2:03 pm - DI 84)

**Citations Affected:** IC 20-30.

**Synopsis:** Instruction on human sexuality. Requires each school corporation to make available for inspection to a parent of a student instructional material used in connection with instruction on human sexuality. Prohibits a school from providing a student with instruction on human sexuality unless the parent of the student or the student (if the student is an adult or an emancipated minor) consents to the instruction. Establishes requirements regarding the consent form. Requires the department of education and the governing body of a school corporation to give parents and students notice of these requirements.

**Effective:** July 1, 2018.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

1           SECTION 1. IC 20-30-5-17, AS AMENDED BY P.L.286-2013,  
2 SECTION 95, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2018]: Sec. 17. (a) ~~A~~ **Each** school corporation shall make  
4 available for inspection by the parent of a student any instructional  
5 materials, including  
6           (1) teachers' manuals,  
7           (2) curricular materials,  
8           (3) films or other video materials,  
9           (4) tapes, and  
10          (5) other materials,  
11 used in connection with:  
12          (1) a personal analysis, an evaluation, or a survey described in  
13 subsection (b); **or**  
14          (2) **instruction on human sexuality, including sexual activity,**  
15          **sexual orientation, and gender identity.**  
16          (b) A student shall not be required to participate in a personal  
17 analysis, an evaluation, or a survey that is not directly related to

1 academic instruction and that reveals or attempts to affect the student's  
 2 attitudes, habits, traits, opinions, beliefs, or feelings concerning:

- 3 (1) political affiliations;  
 4 (2) religious beliefs or practices;  
 5 (3) mental or psychological conditions that may embarrass the  
 6 student or the student's family;  
 7 (4) sexual behavior or attitudes;  
 8 (5) illegal, antisocial, self-incriminating, or demeaning behavior;  
 9 (6) critical appraisals of other individuals with whom the student  
 10 has a close family relationship;  
 11 (7) legally recognized privileged or confidential relationships,  
 12 including a relationship with a lawyer, minister, or physician; or  
 13 (8) income (except as required by law to determine eligibility for  
 14 participation in a program or for receiving financial assistance  
 15 under a program);

16 without the prior consent of the student if the student is an adult or an  
 17 emancipated minor or the prior written consent of the student's parent  
 18 if the student is an unemancipated minor. A parental consent form for  
 19 a personal analysis, an evaluation, or a survey described in this ~~section~~  
 20 **subsection** shall accurately reflect the contents and nature of the  
 21 personal analysis, evaluation, or survey.

22 **(c) A school may not provide a student with instruction on**  
 23 **human sexuality, including sexual activity, sexual orientation, or**  
 24 **gender identity, unless the parent of the student or the student, if**  
 25 **the student is an adult or an emancipated minor, has provided the**  
 26 **school with written consent for the instruction. A consent form**  
 27 **provided to a parent of a student or a student under this subsection**  
 28 **must accurately reflect the contents and nature of the instruction**  
 29 **on human sexuality that will be provided to the student.**

30 ~~(c)~~ **(d)** The department and the governing body shall give parents  
 31 and students notice of their rights under this section.

32 ~~(d)~~ **(e)** The governing body shall enforce this section.
