

# **SENATE BILL No. 72**

DIGEST OF SB 72 (Updated February 12, 2015 1:40 pm - DI 55)

Citations Affected: Noncode.

**Synopsis:** Motor vehicle manufacturer sales. Urges the legislative council to assign to the appropriate study committee for the 2015 interim the task of studying the sale by a motor vehicle manufacturer of new motor vehicles directly to consumers other than through an independent franchised new motor vehicle dealer that has a physical place of business capable of performing complete warranty service on motor vehicles produced by the manufacturer.

Effective: Upon passage.

A BILL FOR AN ACT concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. [EFFECTIVE UPON PASS	SAGE] (a) As t	used in this
SECTION, "interim" has the meaning se	et forth in IC	2-5-1.3-1.

- (b) As used in this SECTION, "legislative council" refers to the legislative council established by IC 2-5-1.1-1.
- (c) As used in this SECTION, "study committee" means an interim study committee established by IC 2-5-1.3-4.
- (d) The general assembly urges the legislative council to assign to the appropriate study committee for the 2015 interim the task of studying the sale by a motor vehicle manufacturer of new motor vehicles directly to consumers other than through an independent franchised new motor vehicle dealer that has a physical place of business capable of performing complete warranty service on motor vehicles produced by the manufacturer.
- (e) If the topic set forth in subsection (d) is assigned to a study committee, the study committee shall issue to the legislative council a final report containing the study committee's findings and

2	concerning the topic, in an electronic format under IC 5-14-6 not
