**Synopsis:** School curriculum. Requires each school corporation and accredited nonpublic elementary school to include cursive writing in its curriculum. Requires each school corporation and accredited nonpublic school to include reading in its curriculum.

**Effective:** July 1, 2016.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 2015 Regular Session of the General Assembly.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

14 ~~(4)~~ **(4)** Social studies and citizenship, including the:

16 (B) governmental systems; and  
17 (C) histories;

16 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
17 1, 2016]: **Sec. 7.3. An accredited nonpublic school shall include in**  
18 **the accredited nonpublic school's curriculum studies in reading.**
