

SENATE BILL No. 85

DIGEST OF SB 85 (Updated January 10, 2022 1:25 pm - DI 129)

Citations Affected: IC 2-5.

Synopsis: Drainage task force. Establishes a drainage task force consisting of six members of the senate, six members of the house of representatives, and six other individuals. Requires the task force to: (1) review the responsibilities of landowners and state and local authorities under current laws relating to the drainage of land; (2) make certain determinations concerning drainage and regulatory matters; and (3) determine whether the balance between state authority and local authority over drainage of agricultural land favors state authority more in Indiana than in neighboring states. Authorizes the task force to make recommendations. Requires the task force to issue a report and, not later than December 1, 2023, submit the report to the executive director of the legislative services agency for distribution to the members of the general assembly and to the governor.

Effective: Upon passage.

SENATE BILL No. 85

A BILL FOR AN ACT to amend the Indiana Code concerning agriculture.

Be it enacted by the General Assembly of the State of Indiana:

4	Chapter 51. Drainage Task Force
5	Sec. 1. As used in this chapter, "task force" refers to the
6	drainage task force established by section 2 of this chapter.
7	Sec. 2. The drainage task force is established.
8	Sec. 3. (a) The task force consists of the following eighteen (18)
9	members:
0	(1) Six (6) members of the senate, appointed as follows:
1	(A) Four (4) members shall be appointed by the president
2	pro tempore.
3	(B) Two (2) members shall be appointed by the minority
4	leader of the senate.
5	(2) Six (6) members of the house of representatives, appointed
6	as follows:
7	(A) Four (4) members shall be appointed by the speaker.



1	(B) Two (2) members shall be appointed by the minority
2	leader of the house of representatives.
3	(3) One (1) officer or employee of the department of
4	environmental management, appointed by the governor.
5	(4) One (1) officer or employee of the department of natural
6	resources, appointed by the governor.
7	(5) One (1) member of a county drainage board established by
8	IC 36-9-27-4, appointed by the governor.
9	(6) One (1) member of the governing body of a soil and water
10	conservation district who was appointed or elected under
11	IC 14-32-4-1, appointed by the governor.
12	(7) One (1) representative of the Indiana chapter of the
13	American Society of Farm Managers and Rural Appraisers,
14	Inc., appointed by the governor.
15	(8) One (1) representative of a statewide farm organization,
16	appointed by the governor.
17	(b) The president pro tempore shall designate one (1) of the
18	members appointed under subsection (a)(1)(A) as co-chair of the
19	task force.
20	(c) The speaker shall designate one (1) of the members
21	appointed under subsection (a)(2)(A) as co-chair of the task force.
22	Sec. 4. (a) Ten (10) members of the task force constitutes a
23	quorum.
24	(b) The affirmative vote of at least a majority of the members at
25	a meeting at which a quorum is present is necessary for the task
26	force to take official action other than to meet and take testimony.
27	(c) The task force shall meet at the call of the co-chairs.
28	Sec. 5. All meetings of the task force shall be open to the public
29	in accordance with and subject to IC 5-14-1.5. All records of the
30	task force shall be subject to the requirements of IC 5-14-3.
31	Sec. 6. The task force shall do the following:
32	(1) Review the responsibilities of landowners and state and
33	local authorities under current laws relating to the drainage
34	of land, including the following:
35	(A) IC 36-9-27, IC 36-9-27.4, and IC 14-27-8, the laws
36	concerning drains, drainage boards, and drainage
37	maintenance and repair districts.
38	(B) The law concerning federally regulated wetlands,
39	including Sections 404 and 401 of the federal Clean Water
40	Act (33 U.S.C. 1344 and 33 U.S.C. 1341).
41	(C) IC 13-18-22, the law regulating wetland activity in
42	state regulated wetlands.



1	(D) IC 14-28, the Indiana flood control law.
2	(2) Determine:
3	(A) whether authority over drainage matters is shifting
4	from county drainage boards to state authorities;
5	(B) the extent to which the objective inherent in the
6	drainage law, that of simply draining agricultural land, is
7	yielding to conservation and pollution control objectives;
8	(C) whether the delays and costs associated with
9	regulatory requirements applying to farm conservation
10	projects are too great; and
11	(D) whether floodway permit requirements should apply
12	to the installation of fences and the removal of embedded
13	tree limbs and stumps on farmland located in floodways.
14	(3) Determine whether the balance between state authority
15	and local authority over drainage of agricultural land favors
16	state authority more in Indiana than in neighboring states.
17	Sec. 7. The task force may make recommendations based upon
18	the determinations it makes under section 6 of this chapter.
19	Sec. 8. The task force shall:
20	(1) issue a report setting forth the determinations and
21	recommendations it makes under this chapter; and
21 22 23 24 25	(2) not later than December 1, 2023, submit the report:
23	(A) in an electronic format under IC 5-14-6 to the
24	executive director of the legislative services agency for
25	distribution to the members of the general assembly; and
26 27	(B) to the governor.
27	Sec. 9. The legislative services agency shall provide staff support
28	to the task force.
29	Sec. 10. This chapter expires January 1, 2024.
30	SECTION 2. An emergency is declared for this act.

Page 1, line 8, delete "seventeen (17)" and insert "eighteen (18)".

"(4) One (1) officer or employee of the department of natural resources, appointed by the governor.".

Page 2, line 5, delete "(4)" and insert "(5)".

Page 2, line 7, delete "(5)" and insert "(6)".

Page 2, line 10, delete "(6)" and insert "(7)".

Page 2, line 13, delete "(7)" and insert "(8)".

Page 2, line 20, delete "A majority of the" and insert "Ten (10)".
