

ENGROSSED SENATE BILL No. 85

DIGEST OF SB 85 (Updated February 7, 2022 11:24 am - DI 140)

Citations Affected: IC 2-5.

Synopsis: Drainage task force. Establishes a drainage task force consisting of six members of the senate, six members of the house of representatives, and seven other individuals. Requires the task force to: (1) review the responsibilities of landowners and state and local authorities under current laws relating to the drainage of land; (2) make certain determinations concerning drainage and regulatory matters; and (3) determine whether the balance between state authority and local authority over drainage of agricultural land favors state authority more in Indiana than in neighboring states. Authorizes the task force to make recommendations. Requires the task force to issue a report and, not later than December 1, 2023, submit the report to the executive director of the legislative services agency for distribution to the members of the general assembly and to the governor.

Effective: Upon passage.

ENGROSSED SENATE BILL No. 85

A BILL FOR AN ACT to amend the Indiana Code concerning agriculture.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 2-5-51 IS ADDED TO THE INDIANA CODE AS
2	A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE UPON
3	PASSAGE]:
4	Chapter 51. Drainage Task Force
5	Sec. 1. As used in this chapter, "task force" refers to the
6	drainage task force established by section 2 of this chapter.
7	Sec. 2. The drainage task force is established.
8	Sec. 3. (a) The task force consists of the following nineteen (19)
9	members:
0	(1) Six (6) members of the senate, appointed as follows:
1	(A) Four (4) members shall be appointed by the president
2	pro tempore.
3	(B) Two (2) members shall be appointed by the minority
4	leader of the senate.
5	(2) Six (6) members of the house of representatives, appointed
6	as follows:
7	(A) Four (4) members shall be appointed by the speaker.



1	(B) Two (2) members shall be appointed by the minority
2	leader of the house of representatives.
3	(3) One (1) officer or employee of the department of
4	environmental management, appointed by the governor.
5	(4) One (1) officer or employee of the department of natural
6	resources, appointed by the governor.
7	(5) One (1) member of a county drainage board established by
8	IC 36-9-27-4, appointed by the governor.
9	(6) One (1) member of the governing body of a soil and water
10	conservation district who was appointed or elected under
11	IC 14-32-4-1, appointed by the governor.
12	(7) One (1) representative of the Indiana chapter of the
13	American Society of Farm Managers and Rural Appraisers,
14	Inc., appointed by the governor.
15	(8) One (1) representative of a statewide farm organization,
16	appointed by the governor.
17	(9) One (1) county surveyor, appointed by the governor.
18	(b) The president pro tempore shall designate one (1) of the
19	members appointed under subsection (a)(1)(A) as co-chair of the
20	task force.
21	(c) The speaker shall designate one (1) of the members
22 23	appointed under subsection (a)(2)(A) as co-chair of the task force.
23	Sec. 4. (a) Ten (10) members of the task force constitutes a
24	quorum.
25	(b) The affirmative vote of at least a majority of the members at
26	a meeting at which a quorum is present is necessary for the task
27	force to take official action other than to meet and take testimony.
28	(c) The task force shall meet at the call of the co-chairs.
29	Sec. 5. All meetings of the task force shall be open to the public
30	in accordance with and subject to IC 5-14-1.5. All records of the
31	task force shall be subject to the requirements of IC 5-14-3.
32	Sec. 6. The task force shall do the following:
33	(1) Review the responsibilities of landowners and state and
34	local authorities under current laws relating to the drainage
35	of land, including the following:
36	(A) IC 36-9-27, IC 36-9-27.4, and IC 14-27-8, the laws
37	concerning drains, drainage boards, and drainage
38	maintenance and repair districts.
39	(B) The law concerning federally regulated wetlands,
40	including Sections 404 and 401 of the federal Clean Water
41	Act (33 U.S.C. 1344 and 33 U.S.C. 1341).
42	(C) IC 13-18-22, the law regulating wetland activity in



1	state regulated wetlands.
2	(D) IC 14-28, the Indiana flood control law.
3	(2) Determine:
4	(A) whether authority over drainage matters is shifting
5	from county drainage boards to state authorities;
6	(B) the extent to which the objective inherent in the
7	drainage law, that of simply draining agricultural land, is
8	yielding to conservation and pollution control objectives;
9	(C) whether the delays and costs associated with
0	regulatory requirements applying to farm conservation
l 1	projects are too great; and
12	(D) whether floodway permit requirements should apply
13	to the installation of fences and the removal of embedded
14	tree limbs and stumps on farmland located in floodways.
15	(3) Determine whether the balance between state authority
16	and local authority over drainage of agricultural land favors
17	state authority more in Indiana than in neighboring states.
18	Sec. 7. The task force may make recommendations based upon
19	the determinations it makes under section 6 of this chapter.
20	Sec. 8. The task force shall:
21	(1) issue a report setting forth the determinations and
22	recommendations it makes under this chapter; and
23	(2) not later than December 1, 2023, submit the report:
21 22 23 24	(A) in an electronic format under IC 5-14-6 to the
25	executive director of the legislative services agency for
26	distribution to the members of the general assembly; and
27	(B) to the governor.
28	Sec. 9. The legislative services agency shall provide staff support
29	to the task force.
30	Sec. 10. This chapter expires January 1, 2024.
31	SECTION 2. An emergency is declared for this act.
