DIGEST OF SB 88 (Updated February 8, 2017 4:28 pm - DI 110)

Citations Affected: IC 20-30.

Synopsis: School calendar. Prohibits public schools and accredited nonpublic schools from beginning student instructional days for the school year before the last Monday in August, beginning with the 2018-2019 school year.

Effective: July 1, 2018.

SENATE BILL No. 88

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-30-2-9 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2018]: **Sec. 9. (a) This section does not affect a collective**
4 **bargaining agreement between a school employer (as defined in**
5 **IC 20-29-2-15) and an exclusive representative that is entered into**
6 **or renewed before July 1, 2018.**
7 **(b) This section does not affect a contract entered into or**
8 **renewed by a governing body before July 1, 2018.**
9 **(c) Beginning with the 2018-2019 school year, the student**
10 **instructional days that make up a school year may not begin before**
11 **the last Monday in August.**

Page 1, line 7, delete "applies only to" and insert "**does not affect**".

Page 1, line 8, delete "after June 30, 2017." and insert "**before July 1, 2018.**".

Page 1, line 9, delete "2017-2018" and insert "**2018-2019**".

Page 1, line 11, delete "fourth" insert "**last**".
