DIGEST OF SB 97 (Updated February 2, 2017 10:53 am - DI MV)

Citations Affected: IC 20-27.

**Synopsis:** School bus usage. Adds provisions that allow a school bus or special purpose bus to be used for transportation for a Special Olympics event or program.

Effective: July 1, 2017.

## SENATE BILL No. 97

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 20-27-9-5, AS AMENDED BY P.L.182-2009(ss),
2	SECTION 318, IS AMENDED TO READ AS FOLLOWS
3	[EFFECTIVE JULY 1, 2017]: Sec. 5. (a) A special purpose bus may be
4	used:
5	(1) by a school corporation to provide regular transportation of a
6	student between one (1) school and another school but not
7	between the student's residence and the school;
8	(2) to transport students and their supervisors, including coaches,
9	managers, and sponsors to athletic or other extracurricular school
10	activities and field trips;
11	(3) by a school corporation to provide transportation between an
12	individual's residence and the school for an individual enrolled in
13	a special program for the habilitation or rehabilitation of persons
14	with a developmental or physical disability; and
15	(4) to transport homeless students under IC 20-27-12; and
16	(5) for transportation for a Special Olympics event or
17	program.

1	(b) The mileage limitation of section 3 of this chapter does not apply
2	to special purpose buses.
3	(c) The operator of a special purpose bus must be at least
4	twenty-one (21) years of age, be authorized by the school corporation,
5	and meet the following requirements:
6	(1) If the special purpose bus has a capacity of less than sixteen
7	(16) passengers, the operator must hold a valid:
8	(A) operator's;
9	(B) chauffeur's;
10	(C) public passenger chauffeur's; or
11	(D) commercial driver's;
12	license.
13	(2) If the special purpose bus has a capacity of more than fifteen
14	(15) passengers, the operator must meet the requirements for a
15	school bus driver set out in IC 20-27-8.
16	(d) A special purpose bus is not required to be constructed,
17	equipped, or painted as specified for school buses under this article or
18	by the rules of the committee.
19	(e) An owner or operator of a special purpose bus, other than a
20	special purpose bus owned or operated by a school corporation or a
21	nonpublic school, is subject to IC 8-2.1.
22	SECTION 2. IC 20-27-9-13.5 IS ADDED TO THE INDIANA
23	CODE AS A NEW SECTION TO READ AS FOLLOWS
24	[EFFECTIVE JULY 1, 2017]: Sec. 13.5. The governing body of a
25	school corporation may allow, by written authorization, the use of
26	a school bus for transportation for a Special Olympics event or
$\frac{1}{27}$	program.
28	SECTION 3. IC 20-27-9-14, AS ADDED BY P.L.1-2005,
29	SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
30	JULY 1, 2017]: Sec. 14. The governing body of a school corporation
31	that authorizes the operation of a school bus under sections 1 through
32	13 13.5 of this chapter shall file proof of financial responsibility as
33	required by IC 9-25.
