DIGEST OF SB 105 (Updated February 15, 2018 8:57 am - DI 84)

Citations Affected: IC 15-11; IC 15-15; IC 15-17; IC 15-19; IC 34-6; IC 34-30; IC 35-52.

Synopsis: State agriculture and animal certification programs. Removes responsibilities concerning the Indiana organic peer review panel from the duties of the Indiana state department of agriculture. Repeals certain statutes concerning the following: (1) Indiana organic certification accreditation. (2) Certification of agricultural products. (3) Livestock certification. Relocates statutes concerning livestock certification to the animal health law. Makes conforming amendments.

Effective: July 1, 2018.

ENGROSSED SENATE BILL No. 105

A BILL FOR AN ACT to amend the Indiana Code concerning agriculture and animals.

Be it enacted by the General Assembly of the State of Indiana:
