SENATE BILL No. 109

DIGEST OF SB 109 (Updated January 30, 2020 2:21 pm - DI 128)

Citations Affected: IC 34-11; IC 35-41.

Synopsis: Statute of limitations. Provides that an otherwise barred offense may be commenced not later than five years from the earlier of the date on which: (1) the state first discovers DNA evidence sufficient to charge the offender; (2) the state first becomes aware of a recording that provides evidence sufficient to charge the offender; or (3) a person confesses to the offense. Removes the statute of limitations for civil causes of action alleging child sexual abuse, and provides that a person who alleges an injury resulting from child sexual abuse may file an action in an otherwise time barred case any time before the date the alleged injured person reaches 31 years of age. Provides that, if the injured person is 31 years of age or older, an civil cause of action alleging child sexual abuse may only be revived if: (1) the cause of action is brought against the alleged perpetrator; and (2) certain new evidence is discovered.

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 34-11-2-4, AS AMENDED BY P.L.44-2013,
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2020]: Sec. 4. (a) An action for:
4 (1) injury to person or character;
5 (2) injury to personal property; or

7 must be commenced within two (2) years after the cause of action

 19 JULY 1, 2020]: Sec. 2. (a) Except as otherwise provided in this section,
 20 a prosecution for an offense is barred unless it is commenced:
- 21 (1) within five (5) years after the commission of the offense, in
 22 the case of a Class B, Class C, or Class D felony (for a crime
 23 committed before July 1, 2014) or a Level 3, Level 4, Level 5, or
 24 Level 6 felony (for a crime committed after June 30, 2014); or
- 25 (2) within two (2) years after the commission of the offense, in the
 26 case of a misdemeanor.
- 27 (b) A prosecution for a Class B or Class C felony (for a crime
 28 committed before July 1, 2014) or a Level 3, Level 4, or Level 5 felony
 29 (for a crime committed after June 30, 2014) that would otherwise be
 30 barred under this section may be commenced within one (1) year after
 31 the earlier of the date on which the state:
- 32 (1) first discovers evidence sufficient to charge the offender with
 33 the offense through DNA (deoxyribonucleic acid) analysis; or
- 34 (2) could have discovered evidence sufficient to charge the
 35 offender with the offense through DNA (deoxyribonucleic acid)
 36 analysis by the exercise of due diligence.
- 37 (c) Except as provided in subsection (e), a prosecution for a Class
 38 A felony (for a crime committed before July 1, 2014) or a Level 1
 39 felony or Level 2 felony (for a crime committed after June 30, 2014)
 40 may be commenced at any time.
- 41 (d) A prosecution for murder may be commenced:
- 42 (1) at any time; and



- 1 (2) regardless of the amount of time that passes between:
2 (A) the date a person allegedly commits the elements of
3 murder; and
4 (B) the date the alleged victim of the murder dies.
- 5 (e) **Except as provided in subsection (p)**, a prosecution for the
6 following offenses is barred unless commenced before the date that the
7 alleged victim of the offense reaches thirty-one (31) years of age:
8 (1) IC 35-42-4-3 (Child molesting).
9 (2) IC 35-42-4-5 (Vicarious sexual gratification).
10 (3) IC 35-42-4-6 (Child solicitation).
11 (4) IC 35-42-4-7 (Child seduction).
12 (5) IC 35-42-4-9 (Sexual misconduct with a minor).
13 (6) IC 35-46-1-3 (Incest).
- 14 (f) A prosecution for forgery of an instrument for payment of
15 money, or for the uttering of a forged instrument, under IC 35-43-5-2,
16 is barred unless it is commenced within five (5) years after the maturity
17 of the instrument.
- 18 (g) If a complaint, indictment, or information is dismissed because
19 of an error, defect, insufficiency, or irregularity, a new prosecution may
20 be commenced within ninety (90) days after the dismissal even if the
21 period of limitation has expired at the time of dismissal, or will expire
22 within ninety (90) days after the dismissal.
- 23 (h) The period within which a prosecution must be commenced does
24 not include any period in which:
25 (1) the accused person is not usually and publicly resident in
26 Indiana or so conceals himself or herself that process cannot be
27 served;
28 (2) the accused person conceals evidence of the offense, and
29 evidence sufficient to charge the person with that offense is
30 unknown to the prosecuting authority and could not have been
31 discovered by that authority by exercise of due diligence; or
32 (3) the accused person is a person elected or appointed to office
33 under statute or constitution, if the offense charged is theft or
34 conversion of public funds or bribery while in public office.
- 35 (i) For purposes of tolling the period of limitation only, a
36 prosecution is considered commenced on the earliest of these dates:
37 (1) The date of filing of an indictment, information, or complaint
38 before a court having jurisdiction.
39 (2) The date of issuance of a valid arrest warrant.
40 (3) The date of arrest of the accused person by a law enforcement
41 officer without a warrant, if the officer has authority to make the
42 arrest.



1 (j) A prosecution is considered timely commenced for any offense
2 to which the defendant enters a plea of guilty, notwithstanding that the
3 period of limitation has expired.

4 (k) The following apply to the specified offenses:

5 (1) A prosecution for an offense under IC 30-2-9-7(b) (misuse of
6 funeral trust funds) is barred unless commenced within five (5)
7 years after the date of death of the settlor (as described in
8 IC 30-2-9).

9 (2) A prosecution for an offense under IC 30-2-10-9(b) (misuse
10 of funeral trust funds) is barred unless commenced within five (5)
11 years after the date of death of the settlor (as described in
12 IC 30-2-10).

13 (3) A prosecution for an offense under IC 30-2-13-38(f) (misuse
14 of funeral trust or escrow account funds) is barred unless
15 commenced within five (5) years after the date of death of the
16 purchaser (as defined in IC 30-2-13-9).

17 (l) A prosecution for an offense under IC 23-2-6, IC 23-2.5,
18 IC 23-14-48-9, or IC 23-19 is barred unless commenced within five (5)
19 years after the earlier of the date on which the state:

20 (1) first discovers evidence sufficient to charge the offender with
21 the offense; or

22 (2) could have discovered evidence sufficient to charge the
23 offender with the offense by the exercise of due diligence.

24 (m) A prosecution for a sex offense listed in IC 11-8-8-4.5 that is
25 committed against a child and that is not:

26 (1) a Class A felony (for a crime committed before July 1, 2014)
27 or a Level 1 felony or Level 2 felony (for a crime committed after
28 June 30, 2014); or

29 (2) listed in subsection (e);

30 is barred unless commenced within ten (10) years after the commission
31 of the offense, or within four (4) years after the person ceases to be a
32 dependent of the person alleged to have committed the offense,
33 whichever occurs later.

34 (n) A prosecution for rape (IC 35-42-4-1) as a Class B felony (for a
35 crime committed before July 1, 2014) or as a Level 3 felony (for a
36 crime committed after June 30, 2014) that would otherwise be barred
37 under this section may be commenced not later than five (5) years after
38 the earlier of the date on which:

39 (1) the state first discovers evidence sufficient to charge the
40 offender with the offense through DNA (deoxyribonucleic acid)
41 analysis;

42 (2) the state first becomes aware of the existence of a recording



1 (as defined in IC 35-31.5-2-273) that provides evidence sufficient
2 to charge the offender with the offense; or

3 (3) a person confesses to the offense.

4 (o) A prosecution for criminal deviate conduct (IC 35-42-4-2)
5 (repealed) as a Class B felony for a crime committed before July 1,
6 2014, that would otherwise be barred under this section may be
7 commenced not later than five (5) years after the earliest of the date on
8 which:

9 (1) the state first discovers evidence sufficient to charge the
10 offender with the offense through DNA (deoxyribonucleic acid)
11 analysis;

12 (2) the state first becomes aware of the existence of a recording
13 (as defined in IC 35-31.5-2-273) that provides evidence sufficient
14 to charge the offender with the offense; or

15 (3) a person confesses to the offense.

16 **(p) A prosecution for an offense described in subsection (e) that**
17 **would otherwise be barred under this section may be commenced**
18 **not later than five (5) years after the earliest of the date on which:**

19 **(1) the state first discovers evidence sufficient to charge the**
20 **offender with the offense through DNA (deoxyribonucleic**
21 **acid) analysis;**

22 **(2) the state first becomes aware of the existence of a**
23 **recording (as defined in IC 35-31.5-2-273) that provides**
24 **evidence sufficient to charge the offender with the offense; or**

25 **(3) a person confesses to the offense.**

Page 1, between the enacting clause and line 1, begin a new paragraph and insert:

"SECTION 1. IC 34-11-2-4, AS AMENDED BY P.L.44-2013, SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2020]: Sec. 4. (a) An action for:

- (1) injury to person or character;
- (2) injury to personal property; or
- (3) a forfeiture of penalty given by statute;

must be commenced within two (2) years after the cause of action accrues.

(b) An action for injury to a person that results from the sexual abuse of a child ~~must may~~ be commenced ~~within the later of:~~

- ~~(1) seven (7) years after the cause of action accrues; or~~
- ~~(2) four (4) years after the person ceases to be a dependent of the person alleged to have performed the sexual abuse: at any time.~~

(c) An action for injury to a person that resulted from the sexual abuse of a child that was time barred before July 1, 2020, is hereby revived. An action described in this subsection is revived even if:

- (1) no action was filed; or**
- (2) an action was filed and dismissed by a court due to the expiration of a statute of limitations.**

However, an action under this subsection may only be commenced before the date the alleged injured person reaches thirty-one (31) years of age.

(d) The evidence required for criminal prosecution under IC 35-41-4-2(b) is not required to revive a civil action under subsection (c)."

(1) the cause of action is brought against the alleged perpetrator; and

(2) one of the following occurs:

(A) Evidence is discovered through DNA (deoxyribonucleic acid) analysis sufficient to support the action.

(B) A recording (as defined in IC 35-31.5-2-273) is discovered which supports the action.

(C) A person confesses to the sexual abuse."
