SENATE BILL No. 111

DIGEST OF SB 111 (Updated February 11, 2019 12:48 pm - DI 133)

Citations Affected: IC 12-23.

Synopsis: Substance abuse prevention grant programs. Requires the division of mental health and addiction to establish and administer the: (1) community and faith based substance abuse programs grant; and (2) community and faith based substance abuse transportation assistance grant program. Sets forth requirements and establishes accounts for the grants. Appropriates \$100,000 annually to the community and faith based substance abuse transportation assistance abuse programs grant. Appropriates \$50,000 annually to the community and faith based substance abuse transportation assistance grant program.

Effective: July 1, 2019.

A BILL FOR AN ACT to amend the Indiana Code concerning human services and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

1 reviewing a submitted grant application, the division shall contact 2 at least one (1) of the following that the applicant has designated in 3 the grant application to obtain input about the applicant's program 4 success: 5 (1) A drug court judge or magistrate. 6 (2) A judge or magistrate who considers drug related 7 prosecutions. 8 (3) The supervising judge of a court alcohol and drug services 9 program. 10 (4) A chief law enforcement officer in the geographical area 11 in which the applicant is providing services. 12 (5) Any other person the division has determined would be 13 acceptable to obtain the input required in this subsection. 14 (c) Not later than April 1, 2020, the division shall select and 15 distribute the awarded grants to the initial grant recipients of the 16 grant described in this section. 17 Sec. 2. There is annually appropriated from the state general 18 fund to the division one hundred thousand dollars (\$100,000) for 19 purposes of the community and faith based substance abuse 20 programs described under section 1 of this chapter, to be deposited 21 into the community and faith based substance abuse programs 22 grant account established by section 3 of this chapter. 23 Sec. 3. (a) The community and faith based substance abuse 24 programs grant account is established within the general fund for 25 the purpose of assisting in the funding of newly established and 26 existing community and faith based substance abuse programs as 27 described in section 1 of this chapter. 28 (b) The account shall be administered by the division. The 29 expenses of administering the account shall be paid from money in 30 the account. 31 (c) Money in the account at the end of a state fiscal year does not 32 revert to the state general fund. 33 (d) Money in the account is continually appropriated for the 34 purposes described in this chapter. 35 SECTION 2. There is annually appropriated from the state general 26 fund to the division fifty thousand dollars (\$50,000) for purposes 27 of the community and faith based substance abuse transportation 28 assistance grant program established under section 1 of this 29 chapter, to be deposited into the community and faith based 30 substance abuse transportation assistance grant program account 31 established by section 3 of this chapter. 32 Sec. 3. (a) The community and faith based substance abuse 33 transportation assistance grant program account is established 34 within the general fund for the purpose of assisting in 35 transportation of participants to a program described in section 1 36 of this chapter. 37 (b) The account shall be administered by the division. The 38 expenses of administering the account shall be paid from money in 39 the account. 40 (c) Money in the account at the end of a state fiscal year does not 41 revert to the state general fund. 42 (d) Money in the account is continually appropriated for the
