DIGEST OF SB 112 (Updated January 25, 2021 4:26 pm - DI 140)

**Citations Affected:** IC 12-15.

**Synopsis:** Medicaid reimbursement for out-of-state hospitals. Requires the office of the secretary of family and social services to reimburse for Medicaid eligible services provided to a Medicaid recipient at a hospital located in a state bordering Indiana at the same Medicaid reimbursement rate at which the office reimburses a hospital in Indiana for the service.

**Effective:** July 1, 2021.

## SENATE BILL No. 112

A BILL FOR AN ACT to amend the Indiana Code concerning Medicaid.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 12-15-15.2 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2021]:

4 **Chapter 15.2. Out-of-State Hospital Reimbursement**  
5 **Sec. 1. This chapter applies to inpatient Medicaid covered**  
6 **services and outpatient Medicaid covered services provided to a**  
7 **Medicaid recipient at a hospital located in a state bordering**  
8 **Indiana.**

9 **Sec. 2. The office of the secretary shall reimburse a hospital**  
10 **located in a state bordering Indiana for a Medicaid recipient**  
11 **receiving Medicaid eligible services at the same reimbursement**  
12 **rate at which the office reimburses a hospital located in Indiana for**  
13 **the service.**

14 **Sec. 3. The office shall apply to the United States Department of**  
15 **Health and Human Services for any state plan amendment or**  
16 **Medicaid waiver necessary to implement and administer this**  
17 **chapter.**

1           **Sec. 4. The office may adopt rules under IC 4-22-2 necessary for**  
2           **the implementation and administration of this chapter.**
