DIGEST OF INTRODUCED BILL

Citations Affected: IC 8-23-2-19.

Synopsis: State highway closings. Requires the Indiana department of transportation (department), before letting a contract for a proposed project that would construct or improve a state highway and require the closure of the state highway for at least five consecutive days, to provide notice of the proposed project to governmental bodies serving the area affected by the proposed highway closure. Authorizes a governmental body, within 30 days after being notified, to submit to the department written objections to the proposed project. Requires the department, if it receives written objections, to respond to the written objections at a regularly scheduled meeting of a governmental body serving the area affected by the proposed highway closure.

SENATE BILL No. 116

A BILL FOR AN ACT to amend the Indiana Code concerning transportation.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 8-23-2-19 IS ADDED TO THE INDIANA CODE
2	AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3	1, 2014]: Sec. 19. (a) This section applies to a contract for a
4	proposed project that would:
5	(1) construct or improve a state highway; and
6	(2) require the closure of a state highway for at least five (5
7	consecutive days.
8	(b) Before letting a contract described in subsection (a), the
9	department shall provide written notice of the proposed project to
0	the following:
1	(1) The county executive of the county in which the proposed
2	highway closure is located.
3	(2) The executive of a municipality that satisfies either of the
4	following:
5	(A) The municipality is the municipality in which the
6	proposed highway closure is located.



1	(B) The municipality is the nearest municipality to the
2	proposed highway closure in the case of a closure
3	occurring in an unincorporated area.
4	(3) The appropriate recipient, if any, among the following:
5	(A) The executive of a township providing fire protection
6	services to the area affected by the proposed highway
7	closure.
8	(B) The board of fire trustees of a fire protection district
9	providing fire protection services to the area affected by
10	the proposed highway closure.
11	(C) The executive of the provider unit of a fire protection
12	territory providing fire protection services to the area
13	affected by the proposed highway closure.
14	(4) The director of any local emergency management
15	organization serving the area affected by the proposed
16	highway closure.
17	(c) A governmental body that receives notice of a proposed
18	project under subsection (b) may object to the proposed highway
19	closure by submitting the reasons for the governmental body's
20	objections to the department, in writing, not later than thirty (30)
21	days after receiving the notice.
22	(d) The department shall respond to an objection received under
23	subsection (c) at a regularly scheduled meeting of one (1) of the
24	following:
25	(1) The board of commissioners of the county in which the
26	proposed highway closure is located.
27	(2) The fiscal body of the county in which the proposed
28	highway closure is located.
29	(3) The fiscal body of the appropriate municipality described
30	in subsection (b)(2).
31	(e) The department may alter a proposed project described in
32	subsection (a) to mitigate the effects of the proposed highway
33	closure. However, the department's decisions under this section:
34	(1) are final; and
35	(2) are not subject to judicial review.
