

SENATE BILL No. 132

DIGEST OF INTRODUCED BILL

Citations Affected: IC 6-3-2-4.

Synopsis: State income tax exemption for military income. Provides a 100% state income tax deduction for all military service income received by an individual or the individual's surviving spouse. Removes the minimum age requirement for an individual to deduct income received as retirement or survivor's benefits for military service.

Effective: January 1, 2016.

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 6-3-2-4, AS AMENDED BY P.L.6-2012,
2 SECTION 49, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE

10 United States, including the army, navy, air force, coast guard, marine
11 corps, merchant marine, Indiana army national guard, or Indiana air
12 national guard. ~~However, a person who is less than sixty (60) years of~~
13 ~~age on the last day of the person's taxable year, is not, for that taxable~~
14 ~~year, entitled to a deduction under this section for retirement or~~
15 ~~survivor's benefits.~~
16 (b) **Except as provided in subsection (c), an individual, or the**



1 individual's surviving spouse, is entitled to an adjusted gross
2 income tax deduction for all military service income received by
3 the individual or the individual's surviving spouse during the
4 taxable year and included in federal adjusted gross income under
5 the Internal Revenue Code.

6 ~~(b)~~ (c) An individual whose qualified military income is subtracted
7 from the individual's federal adjusted gross income under
8 IC 6-3-1-3.5(a)(21) for Indiana individual income tax purposes is not,
9 for that taxable year, entitled to a deduction under this section for the
10 amount of the individual's qualified military income that is deducted
11 under IC 6-3-1-3.5(a)(21).

12 SECTION 2. [EFFECTIVE JANUARY 1, 2016] (a) IC 6-3-2-4, as
13 amended by this act, applies to taxable years beginning after
14 December 31, 2015.

15 (b) This SECTION expires January 1, 2019.
