DIGEST OF INTRODUCED BILL

Citations Affected: IC 13-11-2; IC 13-30-2-1.

Synopsis: Ban on sale or use of coal tar pavement products. Prohibits the: (1) sale or offer for sale; and (2) application to pavement; of a coal tar pavement product except as required for purposes of research on the effects of the coal tar pavement product on the environment.

Effective: July 1, 2019.
