DIGEST OF SB 137 (Updated January 13, 2014 1:30 pm - DI 106)

**Citations Affected:** IC 2-5.

**Synopsis:** Adult protective services study committee. Requires the legislative council to establish the adult protective services study committee to study adult protective services in Indiana.

Effective: Upon passage.

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

  - (10) The executive director of the Indiana prosecuting attorneys council or the executive director's designee.".
