## SENATE BILL No. 139

#### DIGEST OF INTRODUCED BILL

Citations Affected: Noncode.

**Synopsis:** School accountability and teacher evaluations. Provides that the state board of education may not place a school or school corporation in a category or designation of school improvement based on the ISTEP program test scores for the 2014-2015 or the 2015-2016 school year. Provides that the ISTEP program test results from the ISTEP test taken in the spring of 2015 or 2016 may not be used as part of a certificated employee's performance evaluation conducted during the 2015-2016 or 2016-2017 school year.

**Effective:** July 1, 2015 (retroactive).

### SENATE BILL No. 139

A BILL FOR AN ACT concerning education.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. [EFFECTIVE JULY 1, 2015 (RETROACTIVE	E)] (a)
The definitions in IC 20 apply throughout this SECTION.	

- (b) Notwithstanding IC 20-31-8 and 511 IAC 6.2-6, and subject to the requirements set forth in Indiana's flexibility waiver under 20 U.S.C. 7861, as in effect on January 1, 2015, the state board may not place a school or school corporation in a category or designation of school improvement for the 2014-2015 or 2015-2016 school year. The 2014-2015 and 2015-2016 school years may not be included in any accountability timeline under IC 20-31-9. The 2013-2014 and 2016-2017 school years are considered sequential school years for purposes of applying IC 20-31-9.
- (c) Notwithstanding IC 20-28-11.5-4 or 511 IAC 10-6-4, ISTEP program test scores from the 2014-2015 and 2015-2016 school years, based on the ISTEP program test taken in the spring of 2015 or 2016, may not be used by a school corporation as part of an annual performance plan developed under IC 20-28-11.5-4 to evaluate certificated employees during the 2015-2016 or 2016-2017 school year.
