ENGROSSED SENATE BILL No. 152

A BILL FOR AN ACT to amend the Indiana Code concerning courts and court officers.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 33-33-18-2, AS AMENDED BY P.L.138-2020,
2	SECTION 17, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	JULY 1, 2021]: Sec. 2. (a) The Delaware circuit court is a court of
4	general jurisdiction with six (6) five (5) judges. The divisions of the
5	court shall be known as Delaware circuit court No. 1, No. 2, No. 3, No.
6	4, and No. 5. and No. 6. The county of Delaware constitutes the
7	judicial district of the court and each of the court's divisions. The court
8	shall maintain the following dockets:
9	(1) Small claims.
10	(2) Minor offenses and violations.
11	(3) Criminal.
12	(4) Juvenile.
13	(5) Civil.
14	(6) Probate.
15	(b) The assignment of judges of the court to the dockets specified in
16	subsection (a) shall be by rule of the court.
17	SECTION 2. IC 33-33-18-2.1 IS REPEALED [EFFECTIVE JULY



1	1, 2021]. Sec. 2.1. (a) Notwithstanding section 2 of this chapter,
2	Delaware circuit court No. 6 is established January 1, 2023.
3	(b) The first judge of Delaware circuit court No. 6 shall:
4	(1) be elected at the November 2022 general election;
5	(2) take office January 1, 2023; and
6	(3) serve a term of six (6) years.
7	(c) This section expires January 1, 2029.
