

SENATE BILL No. 155

DIGEST OF INTRODUCED BILL

Citations Affected: IC 33-37.

Synopsis: Court security fees and funds. Requires: (1) the clerk of a circuit court; and (2) the clerk of a city or town court; to collect a court security fee of \$2 in each action in which a person is required to pay a criminal costs fee or a civil costs fee. Requires the clerks to distribute 100% of the court security fees collected to the auditor of state. Requires the auditor of state to transfer the court security fees to each county. Provides that the court security fees are to be: (1) distributed equally among the counties; and (2) deposited in each county's court security fund. Establishes a court security fund in each county to pay for the costs of installing, operating, maintaining, and upgrading security measures, plans, procedures, and systems in and around: (1) courtrooms; and (2) buildings that contain courtrooms; located in the county. Makes an appropriation.

A BILL FOR AN ACT to amend the Indiana Code concerning courts and court officers and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 33-37-5-33 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2014]: **Sec. 33. In each action in which a person is required to**
4 **pay:**
5 **(1) a criminal costs fee under IC 33-37-4-1; or**
6 **(2) a civil costs fee under IC 33-37-4-4;**
7 **the clerk shall collect a court security fee of two dollars (\$2).**
8 SECTION 2. IC 33-37-7-2, AS AMENDED BY P.L.284-2013,
9 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
10 JULY 1, 2014]: Sec. 2. (a) The clerk of a circuit court shall distribute
11 semiannually to the auditor of state as the state share for deposit in the
12 homeowner protection unit account established by IC 4-6-12-9 one
13 hundred percent (100%) of the automated record keeping fees collected
14 under IC 33-37-5-21 with respect to actions resulting in the accused
15 person entering into a pretrial diversion program agreement under
16 IC 33-39-1-8 or a deferral program agreement under IC 34-28-5-1 and



1 for deposit in the state general fund seventy percent (70%) of the
2 amount of fees collected under the following:

- 3 (1) IC 33-37-4-1(a) (criminal costs fees).
4 (2) IC 33-37-4-2(a) (infraction or ordinance violation costs fees).
5 (3) IC 33-37-4-3(a) (juvenile costs fees).
6 (4) IC 33-37-4-4(a) (civil costs fees).
7 (5) IC 33-37-4-6(a)(1)(A) (small claims costs fees).

10 (b) The clerk of a circuit court shall distribute semiannually to the
11 auditor of state for deposit in the state user fee fund established in
12 IC 33-37-9-2 the following:

- 13 (1) Twenty-five percent (25%) of the drug abuse, prosecution,
14 interdiction, and correction fees collected under
15 IC 33-37-4-1(b)(5).
16 (2) Twenty-five percent (25%) of the alcohol and drug
17 countermeasures fees collected under IC 33-37-4-1(b)(6),
18 IC 33-37-4-2(b)(4), and IC 33-37-4-3(b)(5).
19 (3) One hundred percent (100%) of the child abuse prevention
20 fees collected under IC 33-37-4-1(b)(7).
21 (4) One hundred percent (100%) of the domestic violence
22 prevention and treatment fees collected under IC 33-37-4-1(b)(8).
23 (5) One hundred percent (100%) of the highway work zone fees
24 collected under IC 33-37-4-1(b)(9) and IC 33-37-4-2(b)(5).
25 (6) One hundred percent (100%) of the safe schools fee collected
26 under IC 33-37-5-18.
27 (7) The following:
28 (A) For a county operating under the state's automated judicial
29 system, one hundred percent (100%) of the automated record
30 keeping fee (IC 33-37-5-21) not distributed under subsection
31 (a).
32 (B) This clause applies before July 1, 2013, and after June 30,
33 2015. For a county not operating under the state's automated
34 judicial system, eighty percent (80%) of the automated record
35 keeping fee (IC 33-37-5-21) not distributed under subsection
36 (a).
37 (C) This clause applies after June 30, 2013, and before July 1,
38 2015. For a county not operating under the state's automated
39 judicial system, five dollars (\$5) of the automated record
40 keeping fee (IC 33-37-5-21) not distributed under subsection
41 (a).

42 (c) The clerk of a circuit court shall distribute monthly to the county

- 2 (1) Seventy-five percent (75%) of the drug abuse, prosecution,
3 interdiction, and correction fees collected under
4 IC 33-37-4-1(b)(5).
- 5 (2) Seventy-five percent (75%) of the alcohol and drug
6 countermeasures fees collected under IC 33-37-4-1(b)(6),
7 IC 33-37-4-2(b)(4), and IC 33-37-4-3(b)(5).
- 8 The county auditor shall deposit fees distributed by a clerk under this
9 subsection into the county drug free community fund established under
10 IC 5-2-11.
- 11 (d) The clerk of a circuit court shall distribute monthly to the county
12 auditor one hundred percent (100%) of the late payment fees collected
13 under IC 33-37-5-22. The county auditor shall deposit fees distributed
14 by a clerk under this subsection as follows:
- 15 (1) If directed to do so by an ordinance adopted by the county
16 fiscal body, the county auditor shall deposit forty percent (40%)
17 of the fees in the clerk's record perpetuation fund established
18 under IC 33-37-5-2 and sixty percent (60%) of the fees in the
19 county general fund.
- 20 (2) If the county fiscal body has not adopted an ordinance
21 described in subdivision (1), the county auditor shall deposit all
22 the fees in the county general fund.
- 23 (e) The clerk of the circuit court shall distribute semiannually to the
24 auditor of state for deposit in the sexual assault victims assistance
25 account established by IC 5-2-6-23(h) one hundred percent (100%) of
26 the sexual assault victims assistance fees collected under
27 IC 33-37-5-23.
- 28 (f) The clerk of a circuit court shall distribute monthly to the county
29 auditor the following:
- 30 (1) One hundred percent (100%) of the support and maintenance
31 fees for cases designated as non-Title IV-D child support cases in
32 the Indiana support enforcement tracking system (ISETS) or the
33 successor statewide automated support enforcement system
34 collected under IC 33-37-5-6.
- 35 (2) The percentage share of the support and maintenance fees for
36 cases designated as Title IV-D child support cases in ISETS or the
37 successor statewide automated support enforcement system
38 collected under IC 33-37-5-6 that is reimbursable to the county at
39 the federal financial participation rate.
- 40 The county clerk shall distribute monthly to the department of child
41 services the percentage share of the support and maintenance fees for
42 cases designated as Title IV-D child support cases in ISETS, or the



1 successor statewide automated support enforcement system, collected
2 under IC 33-37-5-6 that is not reimbursable to the county at the
3 applicable federal financial participation rate.

4 (g) The clerk of a circuit court shall distribute monthly to the county
5 auditor the following:

6 (1) One hundred percent (100%) of the small claims service fee
7 under IC 33-37-4-6(a)(1)(B) or IC 33-37-4-6(a)(2) for deposit in
8 the county general fund.

9 (2) One hundred percent (100%) of the small claims garnishee
10 service fee under IC 33-37-4-6(a)(1)(C) or IC 33-37-4-6(a)(3) for
11 deposit in the county general fund.

12 (h) This subsection does not apply to court administration fees
13 collected in small claims actions filed in a court described in IC 33-34.
14 The clerk of a circuit court shall semiannually distribute to the auditor
15 of state for deposit in the state general fund one hundred percent
16 (100%) of the following:

17 (1) The public defense administration fee collected under
18 IC 33-37-5-21.2.

19 (2) The judicial salaries fees collected under IC 33-37-5-26.

20 (3) The DNA sample processing fees collected under
21 IC 33-37-5-26.2.

22 (4) The court administration fees collected under IC 33-37-5-27.

23 (i) The clerk of a circuit court shall semiannually distribute to the
24 auditor of state for deposit in the judicial branch insurance adjustment
25 account established by IC 33-38-5-8.2 one hundred percent (100%) of
26 the judicial insurance adjustment fee collected under IC 33-37-5-25.

27 (j) The proceeds of the service fee collected under
28 IC 33-37-5-28(b)(1) or IC 33-37-5-28(b)(2) shall be distributed as
29 follows:

30 (1) The clerk shall distribute one hundred percent (100%) of the
31 service fees collected in a circuit, superior, county, or probate
32 court to the county auditor for deposit in the county general fund.

33 (2) The clerk shall distribute one hundred percent (100%) of the
34 service fees collected in a city or town court to the city or town
35 fiscal officer for deposit in the city or town general fund.

36 (k) The proceeds of the garnishee service fee collected under
37 IC 33-37-5-28(b)(3) or IC 33-37-5-28(b)(4) shall be distributed as
38 follows:

39 (1) The clerk shall distribute one hundred percent (100%) of the
40 garnishee service fees collected in a circuit, superior, county, or
41 probate court to the county auditor for deposit in the county
42 general fund.



1 (2) The clerk shall distribute one hundred percent (100%) of the
 2 garnishee service fees collected in a city or town court to the city
 3 or town fiscal officer for deposit in the city or town general fund.

4 (l) The clerk of the circuit court shall distribute semiannually to the
 5 auditor of state for deposit in the home ownership education account
 6 established by IC 5-20-1-27 one hundred percent (100%) of the
 7 following:

8 (1) The mortgage foreclosure counseling and education fees
 9 collected under IC 33-37-5-32 (before its expiration on January
 10 1, 2015).

11 (2) Any civil penalties imposed and collected by a court for a
 12 violation of a court order in a foreclosure action under
 13 IC 32-30-10.5.

14 (m) This subsection applies to a county that is not operating under
 15 the state's automated judicial system. The clerk of a circuit court shall
 16 distribute monthly to the county auditor the following part of the
 17 automated record keeping fee (IC 33-37-5-21) not distributed under
 18 subsection (a) for deposit in the clerk's record perpetuation fund:

19 (1) Twenty percent (20%), before July 1, 2013, and after June 30,
 20 2015.

21 (2) Two dollars (\$2) of each fee collected, after June 30, 2013,
 22 and before July 1, 2015.

23 (n) The clerk of a circuit court shall distribute semiannually to the
 24 auditor of state one hundred percent (100%) of the pro bono legal
 25 services fees collected before July 1, 2017, under IC 33-37-5-31. The
 26 auditor of state shall transfer semiannually the pro bono legal services
 27 fees to the Indiana Bar Foundation (or a successor entity) as the entity
 28 designated to organize and administer the interest on lawyers trust
 29 accounts (IOLTA) program under Rule 1.15 of the Rules of
 30 Professional Conduct of the Indiana supreme court. The Indiana Bar
 31 Foundation shall:

32 (1) deposit in an appropriate account and otherwise manage the
 33 fees the Indiana Bar Foundation receives under this subsection in
 34 the same manner the Indiana Bar Foundation deposits and
 35 manages the net earnings the Indiana Bar Foundation receives

7 **fees shall be distributed equally among the counties for deposit in**
8 **each county's court security fund established under IC 33-37-12.**
9 **The amounts necessary to make the transfers required by this**
10 **subsection are appropriated from the state general fund.**

11 SECTION 3. IC 33-37-7-8, AS AMENDED BY P.L.136-2012,
12 SECTION 19, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
13 JULY 1, 2014]: Sec. 8. (a) The clerk of a city or town court shall
14 distribute semiannually to the auditor of state as the state share for
15 deposit in the homeowner protection unit account established by
16 IC 4-6-12-9 one hundred percent (100%) of the automated record
17 keeping fees collected under IC 33-37-5-21 with respect to actions
18 resulting in the accused person entering into a pretrial diversion
19 program agreement under IC 33-39-1-8 or a deferral program
20 agreement under IC 34-28-5-1 and for deposit in the state general fund
21 fifty-five percent (55%) of the amount of fees collected under the
22 following:

- 23 (1) IC 33-37-4-1(a) (criminal costs fees).
24 (2) IC 33-37-4-2(a) (infraction or ordinance violation costs fees).
25 (3) IC 33-37-4-4(a) (civil costs fees).
26 (4) IC 33-37-4-6(a)(1)(A) (small claims costs fees).
27 (5) IC 33-37-5-17 (deferred prosecution fees).

28 (b) The city or town fiscal officer shall distribute monthly to the
29 county auditor as the county share twenty percent (20%) of the amount
30 of fees collected under the following:

- 31 (1) IC 33-37-4-1(a) (criminal costs fees).
32 (2) IC 33-37-4-2(a) (infraction or ordinance violation costs fees).
33 (3) IC 33-37-4-4(a) (civil costs fees).
34 (4) IC 33-37-4-6(a)(1)(A) (small claims costs fees).
35 (5) IC 33-37-5-17 (deferred prosecution fees).

36 (c) The city or town fiscal officer shall retain twenty-five percent
37 (25%) as the city or town share of the fees collected under the
38 following:

- 39 (1) IC 33-37-4-1(a) (criminal costs fees).
40 (2) IC 33-37-4-2(a) (infraction or ordinance violation costs fees).
41 (3) IC 33-37-4-4(a) (civil costs fees).

 16 prioritized to fund city or town court operations.

 19 services fees collected before July 1, 2017, under IC 33-37-5-31. The

5 SECTION 4. IC 33-37-12 IS ADDED TO THE INDIANA CODE
 6 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
 7 JULY 1, 2014]:

8 **Chapter 12. Court Security Funds**

9 **Sec. 1. As used in this chapter, "fund" refers to a court security**
 10 **fund established under section 2(a) of this chapter.**

11 **Sec. 2. (a) A court security fund is established in each county.**

12 **(b) The fund may be used only to pay for the costs of installing,**
 13 **operating, maintaining, and upgrading security measures, plans,**
 14 **procedures, and systems in and around:**

15 **(1) courtrooms; and**

16 **(2) buildings that contain courtrooms;**

17 **located in the county.**

18 **(c) The fund shall be administered by the county auditor.**

19 **(d) The fund consists of court security fees transferred to the**
 20 **county by the auditor of state under:**

21 **(1) IC 33-37-7-2(o); and**

22 **(2) IC 33-37-7-8(k).**

23 **(e) The expenses of administering the fund shall be paid from**
 24 **money in the fund.**
