DIGEST OF INTRODUCED BILL

Citations Affected: IC 9-29-5-2.

Synopsis: Motorcycle registration fee. Eliminates the portion of the motorcycle registration fee that is currently distributed to the spinal cord and brain injury fund.

Effective: July 1, 2016.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 9-29-5-2, AS AMENDED BY P.L.216-2014,
2 SECTION 78, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2016]: Sec. 2. The fee to register a motorcycle or motor driven
4 cycle is twenty-six dollars and ~~thirty-five~~ **five** cents (~~\$26.35~~) (**\$26.05**).
5 The fee shall be distributed as follows:
6 (1) Twenty-five cents (\$0.25) to the state police building account.
7 (~~2~~) ~~Thirty cents (\$0.30) to the spinal cord and brain injury fund.~~
8 (~~3~~) **(2)** Fifty cents (\$0.50) to the state motor vehicle technology
9 fund.
10 (~~4~~) **(3)** Three dollars (\$3) to the crossroads 2000 fund.
11 (~~5~~) **(4)** For a motorcycle or motor driven cycle registered before
12 July 1, 2019, as follows:
13 (A) One dollar and fifty-five cents (\$1.55) to the integrated
14 public safety communications fund.
15 (B) Five dollars (\$5) to the commission fund.
16 (~~6~~) **(5)** For a motorcycle or motor driven cycle registered after
17 June 30, 2019, six dollars and fifty-five cents (\$6.55) to the

- 2 ~~(7)~~ **(6)** Seven dollars (\$7) to the motorcycle operator safety
- 3 education fund.
- 4 ~~(8)~~ **(7)** Eight dollars and seventy-five cents (\$8.75) to the motor
- 5 vehicle highway account.
