Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in this style type. Additions: Whenever a new statutory provision is being enacted (or a new constitutional

provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or *this style type* reconciles conflicts between statutes enacted by the 2020 Regular Session of the General Assembly.

SENATE BILL No. 158

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

1 2	SECTION 1. IC 16-22-8-21, AS AMENDED BY P.L.88-2006, SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	JULY 1, 2021]: Sec. 21. (a) Not less than seven (7) days before a
4	meeting considering the final passage of a proposed ordinance, the
5	corporation shall publish a notice that the proposed ordinance is
6	pending final action. The notice must be published:
7	(1) one (1) time in two (2) newspapers with general circulation in
8	the county; and
9	(2) on the corporation's official Internet web site during the
10	notice period.
11	Notice of an ordinance establishing a budget must be in accordance
12	with the general law relating to budgets of first class cities.
13	(b) The notice must state the following:
14	(1) The general subject matter of the proposed ordinance.
15	(2) The time and place of the meeting.
16	(3) The proposed ordinance is available from the corporation.
17	(c) The corporation may publish in one (1) notice the general



- subject matter of each ordinance pending final action for which notice 1
- 2 has not been given. 3
- (d) An ordinance is not invalid because the reference to the subject matter of the proposed ordinance was inadequate if the reference is 4
- sufficient to advise the public of the general subject matter. 5
