

## **SENATE BILL No. 169**

DIGEST OF SB 169 (Updated February 8, 2023 11:19 am - DI 140)

Citations Affected: IC 16-18; IC 16-31; noncode.

**Synopsis:** Grants for ambulance purchase. Establishes the rural community ambulance grant pilot program and fund. Provides that the program and fund are administered by the emergency medical services commission (commission). Provides that the commission shall award grants on a competitive basis. Makes an appropriation.

Effective: July 1, 2023.

## SENATE BILL No. 169

A BILL FOR AN ACT to amend the Indiana Code concerning public safety and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

17	JULY 1, 2023]: Sec. 7. (a) The commission shall do the following:
18	(1) Develop and promote, in cooperation with state, regional, and
19	local public and private organizations, agencies, and persons, a
20	statewide program for the provision of emergency medical
21	services that must include the following:
22	(A) Preparation of state, regional, and local emergency
23 24	ambulance service plans.
24	(B) Provision of consultative services to state, regional, and
25	local organizations and agencies in developing and
26	implementing ambulance service programs.
27	(C) Promotion of a statewide system of emergency medical
28	service facilities by developing minimum standards,
29	procedures, and guidelines in regard to personnel, equipment,
30	supplies, communications, facilities, and location of such
31	centers.
32	(D) Promotion of programs for the training of personnel
33	providing emergency medical services and programs for the
34	education of the general public in first aid techniques and
35	procedures. The training shall be held in various local
36	communities of the state and shall be conducted by agreement
37	with publicly and privately supported educational institutions
38	or hospitals licensed under IC 16-21, wherever appropriate.
39	(E) Promotion of coordination of emergency communications,
40	resources, and procedures throughout Indiana and, in
41	cooperation with interested state, regional, and local public
42	and private agencies, organizations, and persons, the



1	development of an effective state, regional, and loca
2	emergency communications system.
3	(F) Organizing and sponsoring a statewide emergency medica
4	services conference to provide continuing education for
5	persons providing emergency medical services.
6	(2) Regulate, inspect, and certify or license services, facilities
7	and personnel engaged in providing emergency medical services
8	as provided in this article.
9	(3) Adopt rules required to implement an approved system of
10	emergency medical services.
11	(4) Adopt rules concerning triage and transportation protocols for
12	the transportation of trauma patients consistent with the field
13	triage decision scheme of the American College of Surgeons
14	Committee on Trauma.
15	(5) Apply for, receive, and accept gifts, bequests, grants-in-aid
16	state, federal, and local aid, and other forms of financia
17	assistance for the support of emergency medical services.
18	(6) Employ necessary administrative staff.
19	(7) Administer the rural community ambulance grant pilot
20	program and fund under IC 16-31-14. This subdivision
21	expires July 1, 2025.
22	(b) The commission shall include the provision of the mental health
23	first aid training program developed under IC 12-21-5-4 in the
24	promotion of continuing education programs under subsection
25	(a)(1)(D).
26	SECTION 4. IC 16-31-14 IS ADDED TO THE INDIANA CODE
27	AS A <b>NEW</b> CHAPTER TO READ AS FOLLOWS [EFFECTIVE
28	JULY 1, 2023]:
29	Chapter 14. Rural Community Ambulance Grant Pilot Program
30	and Fund
31	Sec. 1. As used in this chapter, "fund" refers to the rura
32	community ambulance grant fund established by section 3 of this
33	chapter.
34	Sec. 2. As used in this chapter, "program" refers to the rura
35	community ambulance grant pilot program established by section
36	4 of this chapter.
37	Sec. 3. (a) The rural community ambulance grant fund is
38	established for the purpose of providing grants under section 4 of
39	this chapter. Administrative expenses necessary to carry out this
40	chapter are also payable from the fund.
41	(b) The fund consists of:
42	(1) grants, gifts, and donations intended for deposit in the

1	fund;
2	(2) appropriations to the fund from other sources; and
3	(3) interest that accrues from money in the fund.
4	(c) The fund shall be administered by the commission. The
5	treasurer of state shall invest the money in the fund not currently
6	needed to meet the obligations of the fund in the same manner as
7	public money is invested. Money in the fund at the end of a state
8	fiscal year does not revert to the state general fund.
9	Sec. 4. (a) The rural community ambulance grant pilot program
10	is established to provide grants to assist with the purchase of an
11	ambulance in rural communities in accordance with section 5 of
12	this chapter.
13	(b) The program is administered by the commission.
14	(c) The commission shall determine the manner in which an
15	applicant may submit an application under section 5 of this
16	chapter.
17	Sec. 5. (a) An applicant may submit an application to the
18	commission if the applicant meets the following requirements:
19	(1) The applicant is located in a county with a population of
20	less than thirty-five thousand (35,000).
21	(2) The applicant is:
22	(A) a nonprofit hospital with less than ninety (90) beds;
23	(B) a fire department, including a volunteer fire
24	department, operated by a unit (as defined in
25	IC 36-1-2-23); or
26	(C) an ambulance service operated by a unit (as defined in
27	IC 36-1-2-23).
28	(3) The applicant demonstrates that at least fifty percent
29	(50%) of the cost of the ambulance will be matched by the
30	applicant.
31	(4) The applicant demonstrates a need for the ambulance and
32	that the ambulance could not be purchased without the grant.
33	(b) Upon receipt of the applications, the commission may award
34	grants on a competitive basis after reviewing the application
35	information submitted under subsection (a). The commission shall
36	give priority to communities with the most need of assistance under
37	this chapter. The maximum grant that an applicant may receive
38	under this chapter is fifty thousand dollars (\$50,000).
39	Sec. 6. This chapter expires July 1, 2025.
40	SECTION 5. [EFFECTIVE JULY 1, 2023] (a) There is
41	appropriated to the rural community ambulance grant fund

established by IC 16-31-14-3, as added by this act:

1	(1) for the state fiscal year beginning after June 30, 2023, and
2	ending before July 1, 2024, five hundred thousand dollars
3	(\$500,000); and
4	(2) for the state fiscal year beginning after June 30, 2024, and
5	ending before July 1, 2025, five hundred thousand dollars
6	(\$500,000);
7	from the state general fund for use by the Indiana emergency
8	medical services commission for its use in carrying out the purpose
9	of the rural community ambulance grant fund.
10	(b) This SECTION expires July 1, 2025.
