

# SENATE BILL No. 177

---

## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 14-8-2-183; IC 14-23-1.

**Synopsis:** Sale of seedlings and wildflower seeds. Relocates a provision that allows the sale and distribution of nursery stock or wildflower seeds to certain individuals who reside in a state other than Indiana. Provides that the department of natural resources (department) may sell and distribute to an individual or a business in a state other than Indiana nursery stock or wildflower seeds that the department determines are excess inventory. Prohibits the department from selling or distributing nursery stock or wildflower seeds to a business that sells nursery stock or wildflower seeds in Indiana. (Current law prohibits the department from selling or distributing nursery stock or wildflower seeds to any business that sells nursery stock or wildflower seeds.) Requires the department to publish certain information concerning nurseries that sell seedlings on the division of forestry's Internet web site. Allows the nurseryman to determine whether the nursery's information is published on the division's Internet web site.

# SENATE BILL No. 177

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 14-8-2-183 IS AMENDED TO READ AS
- 2 FOLLOWS [EFFECTIVE JULY 1, 2014]: Sec. 183. "Nurseryman", for
- 3 purposes of **IC 14-23-1 and** IC 14-24, means a person who owns,
- 4 leases, manages, or controls a nursery.
- 5 SECTION 2. IC 14-23-1-2, AS ADDED BY P.L.82-2007,
- 6 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 7 JULY 1, 2014]: Sec. 2. (a) This section does not apply to the following:
- 8 (1) The sale or distribution of nursery stock or wildflower seeds
- 9 to the following:
- 10 (A) An individual who resides in Indiana.
- 11 (B) A governmental entity.
- 12 (C) A nonprofit organization or an educational institution.
- 13 (D) An agricultural research program.
- 14 (2) The exchange of nursery stock or wildflower seeds with a
- 15 person or an entity.
- 16 **(3) The sale or distribution of nursery stock or wildflower**



1 seeds to an individual who resides in a state other than  
2 Indiana, and who:

3 (A) owns land in Indiana; and

4 (B) submits an affidavit that affirms that the nursery stock  
5 or wildflower seeds will be planted in Indiana.

6 (b) The department may not sell or distribute nursery stock or  
7 wildflower seeds to the following:

8 (1) A business or an individual who resides in a state other than  
9 Indiana, unless: ~~the individual:~~

10 (A) owns land in Indiana; and

11 (B) submits an affidavit that affirms that the nursery stock or  
12 wildflower seeds will be planted in Indiana.

13 (A) the department determines the nursery stock or  
14 wildflower seeds are excess inventory; and

15 (B) the individual or business does not sell or distribute  
16 nursery stock or wildflower seeds in Indiana.

17 (2) A retail business that sells nursery stock or wildflower seeds  
18 in Indiana.

19 (3) A wholesale business that sells nursery stock or wildflower  
20 seeds in Indiana.

21 SECTION 3. IC 14-23-1-3 IS ADDED TO THE INDIANA CODE  
22 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
23 1, 2014]: **Sec. 3. (a) Subject to subsection (b), the department shall  
24 publish on the division of forestry's Internet web site the  
25 information required under subsection (b) if a nurseryman:**

26 (1) whose nursery has been inspected and certified under  
27 IC 14-24-5;

28 (2) who holds a dealer's license under IC 14-24-7; and

29 (3) who sells seedlings of trees or bushes;

30 elects to have the information published on the division's Internet  
31 web site.

32 (b) If a nurseryman described in subsection (a) elects to have  
33 information about a nursery published on the division of forestry's  
34 Internet web site, the nurseryman must submit to the department  
35 on a form prepared by the department the following information:

36 (1) The name of the nursery business.

37 (2) The address of the nursery, including the name of the  
38 county in which the nursery is located.

39 (3) The contact information of the nursery, which may include  
40 the nursery's phone number, electronic mail address, and  
41 Internet web site.

42 (4) Whether the nursery provides retail sales, wholesale sales,



1           **or both.**  
2           **(5) The species of tree and bush seedlings that the nursery**  
3           **offers.**  
4           **(6) Any other information allowed by the department.**  
5           **The information must be submitted before January 1 of each year.**  
6           **(c) Before February 1 of each year, the department shall update**  
7           **the division of forestry's Internet web site with the information**  
8           **required under this section. The information for the Internet web**  
9           **site required under this section may be combined with the**  
10           **information required for the Internet directory under**  
11           **IC 14-24-10-4.**
