# **SENATE BILL No. 178**

DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-18-2; IC 16-19-18.

**Synopsis:** Contact tracing and system. Requires the state department of health (state department) to: (1) perform contact tracing; and (2) establish and maintain a contact tracing reporting system (system) in which specified covered businesses are required to transmit certain customer information to the system. Sets forth requirements for the software used for the system. Specifies that the information is confidential. Requires the state department to establish fees for covered businesses to cover the costs of maintaining the system. Requires covered business to report certain data. Establishes a Class B infraction for a covered business failing to report data or pay the assessed fees for the system.

Effective: July 1, 2021.

As used in this chapter, "contact tracing reporting 12 system" means a software program created for or adopted by the 13 state department to assist in collecting data from covered 14 businesses and performing contact tracing by deriving the 15 following from contact tracing: 16 (1) Processing or analyzing data. 17 (2) Recording or capturing data. 18 (3) Facilitating the compilation and organization of data. 19 (4) Processing the capability of reporting historical or current 20 data. 21 Sec. 3. As used in this chapter, "covered business" refers to the 22 following: 23 (1) A hospital licensed under IC 16-21. 24 (2) A state educational institution (as defined in 25 IC 21-7-13-32). 26 (3) A hotel. 27 (4) An airport, airport authority, or commercial airline. 28 Sec. 4. The state department shall perform contact tracing for 29 communicable diseases in order to prevent or limit the 30 transmission of the communicable disease to an uninfected 31 individual. 32 Sec. 5. (a) The state department shall establish and maintain a 33 contact tracing reporting system. 34 (b) The state department may contract with an entity to assist 35 in the establishment and maintenance of the contact tracing 36 reporting system. 37 (c) In selecting a software system to use for the contact tracing 38 reporting system, the state department may only consider software 39 that meets the following: 40 (1) Is designed to allow data to reside exclusively on 41 computers, servers, networks, devices, or other infrastructure 42 that is owned, operated, maintained, and overseen by or on

1 behalf of the state. 2 (2) Is hosted or produced by a person that is subject to the 3 jurisdiction of the United States. 4 (3) Is designed for the purpose of performing contact tracing. 5 (4) Is capable of contact tracing for multiple communicable 6 diseases. 7 (5) Is an intelligent business process management system. 8 (6) Uses a compliant business process management notation 9 that uses a graphical representation for specifying business 10 processes in a business process model. 11 (7) Complies with the General Data Protection Regulation of 12 the European Parliament and of the Council of 27. 13 (8) Utilizes a low code or zero code compliant platform. 14 (9) Is not owned or operated by a publicly traded business. 15 Sec. 6. (a) Except as provided in subsection (b), all data or 16 information collected, compiled, stored, processed, or analyzed is 17 confidential under IC 16-41-8-1 and may only be released as 18 specified under IC 16-41-8-1(b). 19 (b) The state department may grant federal and state officials 20 access as any law requires. 21 Sec. 7. (a) The state department shall establish a procedure for 22 a covered business to collect, transmit, and submit data to the 23 state's contact tracing reporting system as required under this 24 chapter. 25 (b) The state department shall establish and collect fees from a 26 covered business for the maintenance of the contact tracing 27 reporting system. 28 Sec. 8. (a) A covered business shall collect, transmit, and submit 29 data to the contact tracing reporting system in the manner 30 determined by the state department. Data that must be collected 31 under this section includes the following: 32 (1) Name of covered business. 33 (2) Name of each customer. 34 (3) Date of customer's visit. 35 (4) Time of customer's visit. 36 (5) Contact information for the customer, including either a 37 phone number or electronic mail address. 38 (b) A covered business shall pay the fees described in section 39 7(b) of this chapter and assessed to the covered business by the 40 state department. 41 (c) A covered business that violates this section commits a Class 42 **B** infraction.
