A BILL FOR AN ACT concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

11 (4) **Consider proposing a statewide program to assist with**
12 **county level adult protective service programs.**
13 (5) **Review programs in other states regarding:**
14 (A) **elder abuse prevention;**
15 (B) **financial exploitation of the elderly; and**
16 (C) **physical and mental abuse of the elderly.**
17 (6) **Evaluate whether funding for adult protective services is**

1 **sufficient.**
2 **(7) Make recommendations, including recommended**
3 **legislation, to the general assembly on how to improve adult**
4 **protective services in Indiana.**
5 **(b) The committee shall issue to the legislative council a final**
6 **report containing the committee's findings and recommendations,**
7 **including any recommended legislation, in an electronic format**
8 **under IC 5-14-6 not later than November 1, 2015.**
9 **(c) This SECTION expires January 1, 2016.**
10 **SECTION 2. An emergency is declared for this act.**
